Formal tenders sealed and clearly marked **TD-04/07/2022: SUPPLY AND DELIVERY OF TLB AND ACCESSORIES – ONCE OFF** must be placed in the Municipal tender box, 26 Church Street, OUDTSHOORN no later than **12h00 on Monday, 05 August 2022** and will be opened in public immediately thereafter in the **Supply Chain Management Office, 26 Church Street, OUDTSHOORN or any alternative place in Oudtshoorn Municipal Offices.**

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R337-00 including VAT** for hard copies directly printed by the Municipality **or free of charge when provided on pdf via e-mail**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Formal Tender TD-04/07/2022 will be evaluated and adjudicated in terms of **80/20** Preference Point System prescribed by the Oudtshoorn Municipality's Supply Chain Management Policy. Further note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za

Further note that Local Content and Production will form part of evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.
