2.2. LANGUAGE

2.3. GOVERNING LAW

4. CONFIDENTIAL NATURE OF DOCUMENTS

The content of the Bid Documents is private and confidential and copyright in every aspect thereof remains vested in the Council. 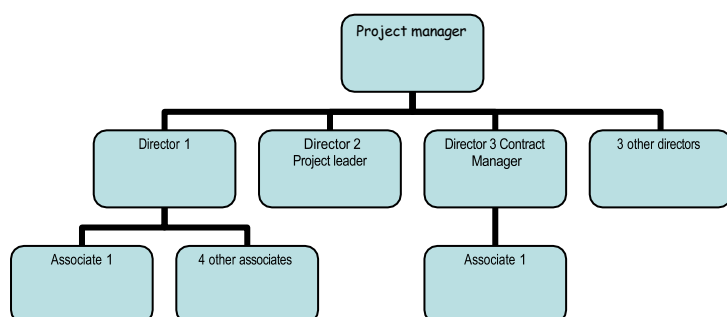
