Add the following clauses: under PSDK 8

PSDK 8.2.4	Geotextile
	Delete the contents of Sub-clause 8.2.4 and replace with the following:
	"The area measured will be that of the nett area of geotextile used.
	The rate shall cover the cost of supplying geotextile, cutting, waste, placing, joining, overlapping and fastening the geotextile in position."
PSDK 8.2.6*	Unpack Damaged Gabions Unit : m <sup>3</sup>
	The rate shall include all labour and supervision to unlace, open, unpack and remove the existing gabions and reno mattress, retaining the cages and stones for re-use.
PSDK 8.2.7	Reinstate Existing Gabions
	The rate shall include all labour and supervision to straighten and reposition the existing gabions or reno mattress once emptied, relace the cages and repack with stones previously removed.
PSDK 8.2.8	Provide Additional Cages (provisional)
	The rate shall cover the cost of procuring and delivering to the work site new gabion cages of the size specified. This item shall only be used on instruction from the Engineer in the event that some of the original cages are not reusable.

	The rate shall cover all costs to source and deliver to the work site stones of the same type and size as originally used. This item shall only be used on instruction from the Engineer in the event that some of the original stones are not recoverable.

#### PSL 8.2.14 Manholes

Add the following to PSL 8.2.4

"The rate shall include for all labour and materials required for breaking into the existing structure, cutting to size and laying of pipes, reinstatement of / or new benching – where ordered by the Engineer – making good around the pipe with an approved repair material, and including all necessary reinstatement around the structure on completion of the connection."

PSL 8.2.16\* Supply and install sluice gates in existing manhole ............. Unit: No. or Sum

The tendered rate shall cover all costs of supplying and installing the sluice gate in the relevant existing manhole structure, including all plant, labour and materials required for the complete and satisfactory installation of the sluice gate specified.

PMA 11.4 Scheduled Items

#### PMA 11.4.6 Primary Settling Tanks

The rate shall include for the provision of all plant and labour to remove water, sand and sludge from the PSTs, loading, carting and disposal of dry sludge at the Hammersdale solid waste disposal site and wet sludge at the Southern WWTW. The rate shall also include for any fees payable at the disposal sites. Separate rates shall not be paid for dry and wet sludge.

Payment will only be made on submission of proof of disposal at either site in the form of official disposal slips issued at the solid waste site or WWTW.

Water may be pumped to the head of the works for disposal. If this option is undertaken, the Contractor shall allow under this item for all costs associated with providing, operating, maintaining, moving and removal from site on completion of the work, all temporary pumps, pipework, labour and materials required.

The rate shall cover all costs for removal of the sludge draw-off pipe work in all five PSTs including breaking out, labour, adhering to all asbestos safety regulations including provision of specialised safety equipment and PPE, bagging, transporting and disposal at a registered

Hazardous solid waste disposal site. The rate shall also include for any fees payable at the disposal site.

Payment will only be made on submission of proof of disposal at the registered Hazardous solid waste site in the form of official disposal slips issued at the waste site.

## PMA 11.4.7 4MI/day Clarifier

The rate shall include for the provision of all plant and labour to remove water, sand and sludge from the clarifier, loading, carting and disposal of dry sludge at the Hammersdale solid waste disposal site and wet sludge at the Southern WWTW. The rate shall also include for any fees payable at the disposal sites. Separate rates shall not be paid for dry and wet sludge.

Payment will only be made on submission of proof of disposal at either site in the form of official disposal slips issued at the solid waste site or WWTW.

Water may be pumped to the head of the works for disposal. If this option is undertaken, the Contractor shall allow under this item for all costs associated with providing, operating, maintaining, moving and removal from site on completion of the work, all temporary pumps, pipework, labour and materials required.

#### PMA 11.4.8 Secondary Settling Tanks

Remove clause PMA 11.4.8 in its entirety.

## PMA 11.4.9 Sludge Digesters and Pumps

The rates for PMA 11.4.9.2 and PMA 11.4.9.3 above shall include for the provision of all plant and labour to remove sludge from the digesters, loading, carting and disposal of dry sludge at the Hammersdale solid waste disposal site and wet sludge at the Southern WWTW. The rate shall also include for any fees payable at the disposal sites. Separate rates shall not be paid for dry and wet sludge.

Payment will only be made on submission of proof of disposal at either site in the form of official disposal slips issued at the solid waste site or WWTW.
