

ANNEXURE C3.2: SCOPE OF WORK

A) Do the following work on the below listed No. Systems at Rand Water Zukerbosch Water Treatment Plant.

- a) Supply and deliver (19-25) mm Blue Crusher/Concrete stones. (Not Heckets Stones)
- b) Remove plants that may have grown in between old stones.
- c) Sweep away stones that are on the concrete slabs.
- d) Top up the entire area with the thickness not less than 50mm.
- e) Rake level all newly supplied stones and old stones.
- f) Prepare four areas that were excavated before by removing the soil so that crusher stones can be evenly levelled.
- g) Deliveries may not exceed 6 m3 loads truck length on the systems.
- h) Drawings are included to measure the area.

All the above work to be done on the following areas.

- 1. R, S, T & U Systems (Carbonation Bay) $\{(112m \times 5m \times 0.05m) \times 2 = 56m^3\}$
- 2. V, W, X & Y Systems (Carbonation Bay) {(112m x 9m x 0.05m) x 2 = 100.8m³}
- 3. Between the systems R, S, T, U and V, W, X, Y $\{(112m \times 31m \times 0.05m) \times 2 = 347.2m^3\}$.
- 4. Along the paved driveway on the systems $\{(261 \text{m x } 6\text{m x } 0.05\text{m}) \text{ x } 4 = 313.2\text{m}^3\}$.
- 5. Around the flocculators and along their site $\{(112m \times 36m \times 0.05m) \times 2 = 403m^3\}$.
