2 CONDITIONS OF BID

- 2.1. No bid will be accepted from persons in the service of the state as defined in the Municipal Finance Management Act and Regulations.
- 2.2. The bid terms and conditions remain binding to the bidder throughout the contracting period.
- 2.3. A consideration of this bid is subject to governing legislation, including those relating to B-BBEE, the City's development goals, Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations as amended.
- 2.4. That the tender may not necessarily be awarded to the bidder scoring the highest points.
- 2.5. The bidder is prohibited from participating in any form of price manipulation or bid rigging including those in MBD 9. If found, the bidder will be disqualified, or award be terminated.
- 2.6. Negotiations will only be conducted with selected bidder/s where necessary.
- 2.7. An award may be made to more than one bidder.
- 2.8. If considered necessary, the municipality reserves the right to visit the bidder's place of business and/or its customers.
- 2.9. The specifications are the copyright of the municipality.
- 2.10. The municipality reserves the right to cancel the requests for bids at any time or stage before the award or not to accept any bid.
- 2.11. Should it be found that the bidder has not been truthful and/or dishonest, then municipality shall cancel the award and negotiate with the next acceptable bidder.

2.14. Remedies

 - (a) inform the tenderer accordingly; and
 - (b) give the tenderer an opportunity to make representations within 14 days as to why the tender may not be disqualified or, if the tender has already been awarded to the tenderer, the contract should not be terminated in whole or in part.
- (2) After considering the representations referred to in subparagraph (2.14) (b), the City of Johannesburg may, if it concludes that such information is false—
 - (a) disqualify the tenderer or terminate the contract in whole or in part; and
 - (b) if applicable, claim damages from the tenderer.

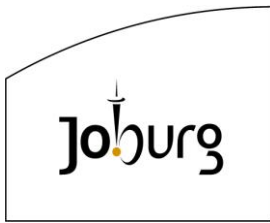
2.15. The tender may be divisible and be awarded to more than one bidder.

3. TERMS AND CONDITIONS FOR BIDDING [Part B – Tax Compliance Requirements]

- 3.1. Bidders must ensure compliance with their tax obligations.

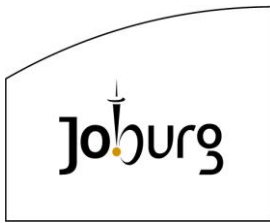

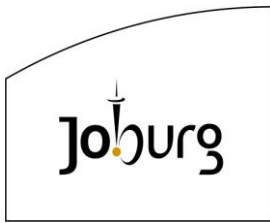

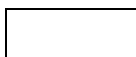

5. GENERAL TERMS AND CONDITIONS OF THE CONTRACT

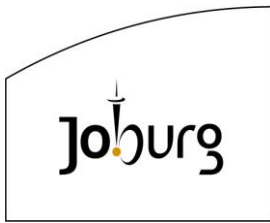
- a) In this document words in the singular also refer to the plural and *vice versa* and words in the masculine also mean in the feminine and neuter.
- b) The General Conditions of Contract (GCC) will form part of all bid documents and may not be amended.
- c) Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the GCC. Whenever there is a conflict, the provisions in the SCC shall prevail.
- d) Wherever the following words appear, they will have interchangeable meaning: "purchaser" refers to the "municipality" and "supplier" refers to the "bidder".

Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.

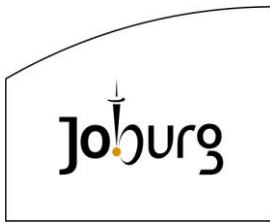

- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery *ex stock*" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "*Force majeure*" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.

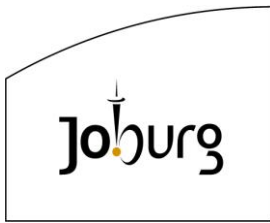
5. Use of contract documents and information; inspection

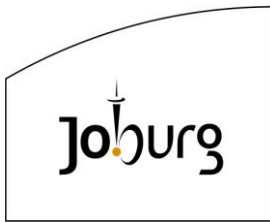
7. Performance security

- 7.1. Within 30 (thirty) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

- 21.4. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.5. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. 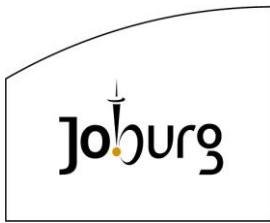

23. Termination for default

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

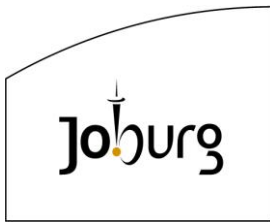

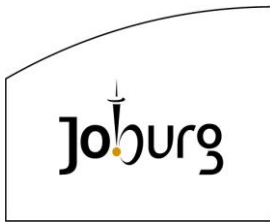

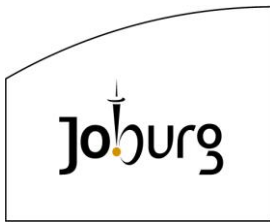

27. Settlement of Disputes

1. INTRODUCTION

- 1.1. The Covid-19 pandemic imposed substantial strain on economies and businesses across the world. Since the beginning of the pandemic in 2020, many businesses have experienced significant decline in revenue and year on year profit; cash flow problems and decline in productivity. As a result, some businesses have deferred or frozen investment and expansion plans while others have closed down, leading to massive job and employment opportunities losses. Governments and international development organisations around the world have responded to the economic impacts of covid-19 with a number of assistance and relief programmes targeting specific economic sectors and industries, individual firms as well as citizens. In South Africa, the difficulty of accessing such assistance has been widely reported by the business community.
- 1.2. As the economic capital of South Africa and a host to the largest number of businesses in South Africa, the City of Joburg has an obligation to play an active and impactful role in providing relevant support and assistance for business retention and expansion amid the volatile economic climate of Covid-19. One of the City's key strategic roles is to create an enabling environment for increased and sustained business activity and economic growth in its regions based on their different profiles and comparative advantages. It is therefore vital for the City to have detailed information about the business climate in the City to enable it to provide appropriate targeted interventions to support business and economic growth in its regions.
- 1.3. Business Retention and Aftercare is key to advance economic development activities as it is less costly to retain existing businesses than to recruit new investments. If implemented well, business retention and aftercare contributes to the retention of existing jobs as well as create opportunities for new job creation as a result of expansions. Furthermore, a successful business retention and aftercare programme will enhance the image and attractiveness of a particular region and therefore create a pool of satisfied businesses that will serve as ambassadors that will help recruit new businesses into the region.
- 1.4. Climate change is driving a drastic global economic transition which will involve opportunities as well as shocks and disequilibrium. South Africa's trading partners are rapidly decarbonising, in order to remain economically competitive as a country it is critical that we ensure that the pace of our economic transition aligns with the global transition. The City of Johannesburg is committed to supporting a just transition towards a low carbon, sustainable and climate resilient economy. The City has an important role to play in coordinating and promoting local economic development to ensure that the job creation potential of the transition is maximised and economic shocks are mitigated. Information is required to understand the current sustainability practices in place within the private sector, how droughts, floods and water and energy supply are impacting businesses and the support required to overcome global transition risks.

1.5. It is against this background that the City's Economic Development Department, which is mandated with providing strategic economic direction to the City, facilitating the creation of an enabling environment that attracts investment and provide dedicated incentive packages for the business community in all regions of the city, is seeking to undertake a business retention and expansion (BR&E) survey to collect detailed information from medium and large businesses operating in the City.

2. PURPOSE OF THE SURVEY
