RBIDZ will not be available for inspection purposes on any other occasion. Tenderers are required to bring their tender documents to the site inspection for signature. **Tenderers without original tender documents and tenderers with original documents arriving after 11h00am will not be allowed to attend the briefing meeting.**

Tenders must be completed in accordance with the conditions attached to the tender document, must be sealed and endorsed with the relevant contract number and must be deposited in the official tender box at the RBIDZ Office Complex, 4 Harbour Arterial, Alton, Richards Bay (GPS 28°46'50.3"S 32°00'54.0"E) **not later than 12h00 on 17 June 2026.**

Tenders will be evaluated in terms price and preference on an **80/20** system as contemplated in the Preferential Procurement Policy Framework Act and must score a minimum of **60%** on functionality to be considered further in terms of price and preference.

In accordance with the RBIDZ Preferential Procurement Policy and Broad Based Black Economic Empowerment Acts and associated Codes of Good Practice, **it is a condition of tender that, only tenderers that are B-BBEE Level 1-4 shall be eligible to tender. Tenderers that do not meet the pre-qualification criteria for preferential procurement shall be immediately disqualified.**
