**DESCRIPTION: REQUEST FOR QUOTATION (RFQ) FROM SUITABLE QUALIFIED SERVICE PROVIDER(S) TO SUPPLY A SOLAR SPATIAL AND STATISTIC ANALYTIC DATASET(S)****SPECIFICATION****1. BACKGROUND**

The City of Johannesburg (CoJ) aims to conduct an internal research project to assess the current status quo of Photovoltaic (PV) coverage and output (in KiloWatts) within Johannesburg.

The research objectives are to:

- 1.1 Provide a spatialised assessment of actual PV coverage and output with regards to:
  - 1.1.1 Compare and evaluate the current actual PV coverage and output against maximum<sup>1</sup> demand forecasting potential coverage and output;
  - 1.1.2 Compare data of current actual coverage against a previous time period to establish an indicative trend in terms of rate of uptake and associated output.
  - 1.1.3 Compare output by land use (e.g. residential, commercial, industrial, agricultural and utility areas)
  - 1.1.4 Comment on potential impact, challenges and opportunities in terms of the City's financial sustainability and anticipated future revenue (i.e. bulk costs and sale of electricity).

**2. OBJECTIVE**

This is a Request for Quotation (RFQ) to procure a solar spatial and statistic analytic dataset(s) which will enable internal COJ researchers to conduct an analysis in order to successfully fulfil the research objectives outlined above.

**3. DELIVERABLES**

The solar spatial and statistic dataset should provide information related to solar energy and spatial distribution of actual solar installation coverage in Johannesburg. The data should be available per Enumerator Area (EA) polygon and cover all EAs within the City of Johannesburg and should therefore be aggregateable to other administrative boundaries. The data should be derived from satellite imagery based on machine learning and data modelling scripts. All dominant high-income residential areas, in Neighbourhood Lifestyle Index (NLI) or Lifestyle Standard Measure (LSM) 7-10, in the city should be completed and immediately available for delivery. EAs containing other NLI or LSM between 1 and 6 for residential areas, should be completed and delivered within 1 month of the Purchase Order (PO) being issued. Solar data for EAs of other landuse types, e.g. commercial, industrial, schools, etc. should be immediately available.

<sup>1</sup> while noting and considering the various conditions that may limit maximum output; such as weather/radiation/building orientation, capital outlay required/LSM/NLI of households, and grid capacity and storage constraints.

The data should contain variables such as the number of buildings with solar, number of households with solar, total kw output index, index for solar uptake potential, total kw output index per land use and index for solar uptake potential per land use among others. The data should be up to date for 2023.

The solar spatial and statistic analytic dataset(s) to be provided by the service provider should include:

- Current (2023) solar analytics information including spatialised Kw output index per land use
- Temporal Solar Analytics Data 20192 versus 2023
- Data to be provided in Excel format,<sup>3</sup> inclusive of spatial identifier: e.g. Enumerated Area (EA) and/ or coordinates
- Access to a map viewer/ web interface version of the data
- Supply of additional spatial GIS data files format to be quoted

#### **4. SCOPE OF WORK**

- Delivery of the relevant dataset(s), as per the specifications of section 3 Deliverables, to CoJ.

Preferred deliverables. These will be considered a competitive advantage:

- CoJ access to the dataset (as acquired at time of procurement) in perpetuity;
- Ad hoc data analysis support and/ or training;
- Provision of relevant existing analysis;
- Provision of supplementary datasets with additional information on households that install solar (neighbourhood lifestyle index (NLI) or LSM, socio-economic/ environmental risks profiles, etc.).
- Upgrades and/or updates to the dataset during the contract period;

#### **5. TIME FRAME**

In accordance with the Municipal Cost Containment Regulations (2019) the successful bidder will be appointed on a time and cost basis with specific start and end dates;

5.1 The duration for delivery will be thirty (30) days.

5.2 The full suite of data should be delivered to the CoJ within thirty (30) days of the Purchase Order being signed and collected.

5.3 The CoJ will make use of the dataset until 30 June 2024. All procured datasets must remain serviceable and accessible to the CoJ within this period, at least.

## **6. PRICING SCHEDULE**

- 6.1 The remuneration rates will be subject to negotiation, not exceeding the rates in the Guide on Hourly Fee Rates for Consultants issued by the Department of Public Service and Administration (DPSA) (here attached)
- 6.2 Bidders must submit a financial proposal which itemizes the cost of each deliverable as per the table below.
- 6.3 Each bidder must determine and indicate the level and number of team members, hours and associated rates required to produce each deliverable. If the space provided on the below pricing schedule is not sufficient, bidders must attach a pricing schedule on the bidder's letterhead indicating all team members and all additional costs (including travel costs) in the structure provided below. The level of each team member must be clearly indicated on the pricing schedule.
- 6.5 Bidders should note that the City shall neither entertain any claims for additional cost nor will it accept proposals to amend or reduce the scope of work once the successful bidder has been appointed. ## **7. SPECIAL CONDITIONS OF CONTRACT**

- 7.2 The bid price must be inclusive of all travel and subsistence-related costs. Bidders are requested to provide an upfront cost against the estimated distance to be travelled in their quote, in order to avoid excessive travel claims at a later stage. All transport costs must be included in the bid price, and additional travel claims will not be entertained.
- 7.3 When including travel and subsistence-related costs, bidders must ensure that such costs are in line with the national travel policy issued by the National Department of Transport, as updated from time to time. Bidders will not be allowed to claim additional travel costs on the contract.
- 7.4 Each deliverable must be submitted timeously and be subject to the approval of the project manager prior to payment being made.

## **10. CONDITION OF AWARD**

Notwithstanding the suppliers' proposal being recommended for award, an award shall not be made to a bidder whose:

11.1 Bids will initially be evaluated on compliance with the bid requirements.

11.2 Bidders that are deemed to be responsive to the compliance evaluation will be further evaluated on functionality, followed by the bidder's costing of the deliverables of the project and evaluation against Preferential Goals

11.3 Proposals that score a minimum of 75 points for functionality will be further evaluated in terms of price and Preferential Goals.

11.4 Evaluations will be based on the threshold and pricing schedule below. The criteria set out in the document shall be applicable and may not be altered after the submissions have been opened.

**MBD 6.1: PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL  
PROCUREMENT REGULATIONS 2022**

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

**NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022**

**1. GENERAL CONDITIONS**

- 1.1 The following preference point systems are applicable to invitations to tender:
  - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- 1.2 The applicable preference point system for this tender is the 80/20 preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
  - (a) Price; and
  - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

	<b>POINTS</b>
<b>PRICE</b>	<b>80</b>
<b>SPECIFIC GOALS</b>	<b>20</b>
<b>Total points for Price and SPECIFIC GOALS</b>	<b>100</b>

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

**2. DEFINITIONS**

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### **3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES**

#### **6.1. POINTS AWARDED FOR PRICE**

##### **6.1.1. THE 80/20 PREFERENCE POINT SYSTEMS**

A maximum of 80 points is allocated for price on the following basis:

**80/20**

$$Ps = 80 \left( 1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

### **6.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT**

#### **6.2.1. POINTS AWARDED FOR PRICE**

A maximum of 80 points is allocated for price on the following basis:

**80/20**

$$Ps = 80 \left( 1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

Where

Ps = Points scored for price of tender under consideration  
Pt = Price of tender under consideration  
Pmax = Price of highest acceptable tender

## 7. POINTS AWARDED FOR SPECIFIC GOALS

7.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

7.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

- d) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result

of that person's conduct;

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
