APPLICATION FOR PROPERTY RATES REBATES

The process of Rebates and Reduction applications will be closing **25 May 2026**.

In an effort to assist the Property Owners of Jozini Municipality in payment of Municipal rates, the Municipality is sensitive to the needs of its people and has agreed to give relief to all qualifying registered Property Owners. Relief will also be granted to different Categories of properties in line with the approved Jozini Municipal Property Rates Policy together with Section 15,16,17,18 and 19 of the Municipal Property Rates Act No. 6 of 2004.

1.Pensioners,Retired and Disabled Persons Rate Rebate
In order to qualify for the rebates a pensioner, a retiree, and a disabled person must: be the registered owner of the property either solely or jointly.

- be living permanently on the property.
- does not own another property in the Municipal area.
- provide proof of identity in the form of an Identity Document
- substantiate items(b), (c) and (d) above by way of a **SWORN** Affidavit before a Commissioner of Oaths.
- Medical Certificate as required by the Municipality if the application relies on a medical basis for the rebate. This applies to the disabled.
- Make application annually on the prescribed form.
- Relief will be in the form of a rebate.

2. Child headed families
Families headed by children will receive a 100% rebate for paying rates, according to monthly household income. To qualify for this rebate the head of the family must:

- minor children who are the head of a household as defined in child headed household;
- live permanently on the property,
- may not own any other property within the Jozini Municipality,
- Make application annually on the prescribed form,
- Relief will be in the form of a rebate

Applications must be accompanied by-

- a certified copy of the Identity Document or any other proof of the owners age which is acceptable to the Municipality;
- sufficient proof of income of the owner and his/her spouse;
- an affidavit from the owner;
- if the owner is a disabled person proof of a disability pension payable by the state must be supplied; and
- if the owner has retired at an earlier stage for medical reasons proof thereof must be submitted.
- Latest Municipal rates account

3. Business, commercial and industrial properties

- Businesses who are operating as lodges, bed and breakfast and hotels can qualify for a rebates, they must make an application in writing in the prescribed form collected from the Municipality.

4.Public Benefit Organizations complying with the following criteria;

- PBO's who can provide proof of ownership of the property and registration as a Public Benefit Organisation in terms of the Income Tax Act conducting one or all of the following specified public activities listed in Part 1 of the 9th Schedule:
 - welfare and humanitarian; or
 - health care; or
 - education; and are registered in terms of the Income Tax Act for tax reductions because of the activities referred to in (10.1.6);
 - Must make application in writing annually in the prescribed form
 - Relief will be in the form of the PBO tariff or exemption
 - The Applicant shall not be state owned.
