**2. PREQUALIFICATION / ELIGIBILITY CRITERIA**

2.1 Only those Respondents who satisfy the following pre-qualification or eligibility criteria are eligible to submit quotations as per section 3.

**3 CIDB Grading**

Only those Respondents who are registered with the CIDB, or are capable of being so prior to the submission of the quotation, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a or higher class of construction works, are eligible to have their quotations evaluated.

Joint ventures are eligible to submit tenders provided that:

- every member of the joint venture is registered with an active CIDB;
- the lead partner has a higher or equivalent contractor active grading designation in the class of construction work; and
- the combined Contractor active grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a Contractor grading designation determined in accordance with the sum quoted for a .... class of construction works or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations

- Reject all Quotations, if it so decides;
- Place an order in connection with this Quotation at any time after the RFQ's closing date;
- Make no award at all.

## **12 PROTECTION OF PERSONAL DATA**

In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. PRASA agrees that it shall only process the information disclosed by Respondents in their response to this bid for the purpose of evaluating and subsequent award of business and in accordance with any applicable law.

Furthermore, PRASA will not otherwise modify, amend or alter any personal data submitted by Respondents or disclose or permit the disclosure of any personal data to any Third Party without the prior written consent from the Respondents. ## **SECTION 5**

### **PRASA GENERAL CONDITIONS OF PURCHASE**

#### **General**

PRASA and the Supplier enter into an order/contract on these conditions to supply the items (goods/services/works) as described in the order/contract.

#### **Conditions**

These conditions form the basis of the contract between PRASA and the Supplier. Notwithstanding anything to the contrary in any document issued or sent by the Supplier, these conditions apply except as expressly agreed in writing by PRASA.

No servant or agent of PRASA has authority to vary these conditions orally. These general conditions of purchase are subject to such further special conditions as may be prescribed in writing by PRASA in the order/contract.

#### **Local Content Obligations**

Respondents are to note that the Local Content commitments made by the successful Respondent(s) will be incorporated as a term of the contract and monitored for compliance. Should the successful Respondent fail to meet its Local obligations, non-compliance penalties shall be applicable. Breach of Local Content obligations also provide PRASA cause to terminate the contract in certain cases where material non-compliance with Local Content requirements are not achieved.

#### **Price and payment**

The price or rates for the items stated in the order/contract may include an amount for price adjustment, which is calculated in accordance with the formula stated in the order/contract.

The Supplier may be paid in one currency other than South African Rand. Only one exchange rate is used to convert from this currency to South African Rand. Payment to the Supplier in this currency other than South African Rand, does not exceed the amounts stated in the order/contract. PRASA pays for the item within 30 days of receipt of the Suppliers correct tax invoice.

#### **Delivery and documents**

The Supplier's obligation is to deliver the items on or before the date stated in the order/contract. Late deliveries or late completion of the items may be subject to a penalty if this is imposed in the order/contract. No payment is made if the Supplier does not provide the item as stated in order/contract.

Where items are to be delivered the Supplier:

Clearly marks the outside of each consignment or package with the Supplier's name and full details of the destination in accordance with the order and includes a packing note stating the contents thereof; On dispatch of each consignment, sends to PRASA at the address for delivery of the items, an advice note specifying the means of transport, weight, number of volume as appropriate and the point and date of dispatch; Sends to PRASA a detailed priced invoice as soon as is reasonably practical after dispatch of the items, and states on all communications in respect of the order the order number and code number (if any).

### **Containers / packing material**

Unless otherwise stated in the order/contract, no payment is made for containers or packing materials or return to the Supplier.

### **Title and risk**

Without prejudice to rights of rejection under these conditions, title to and risk in the items passes to PRASA when accepted by PRASA.

### **Rejection**

If the Supplier fails to comply with his obligations under the order/contract, PRASA may reject any part of the items by giving written notice to the Supplier specifying the reason for rejection and whether and within what period replacement of items or re-work are required.

In the case of items delivered, PRASA may return the rejected items to the Supplier at the Supplier's risk and expense. Any money paid to the Supplier in respect of the items not replaced within the time required, together with the costs of returning rejected items to the Supplier and obtaining replacement items from a third party, are paid by the Supplier to PRASA.

In the case of service, the Supplier corrects non-conformances as indicated by PRASA.

### **Warranty**

Without prejudice to any other rights of PRASA under these conditions, the Supplier warrants that the items are in accordance with PRASA's requirements, and fit for the purpose for which they are intended, and will remain free from defects for a period of one year (unless another period is stated in the Order) from acceptance of the items by PRASA.

### **Indemnity**

The Supplier indemnifies PRASA against all actions, suits, claims, demands, costs, charges and expenses arising in connection therewith arising from the negligence, infringement of intellectual or legal rights or breach of statutory duty of the Supplier, his subcontractors, agents or servants, or from the Supplier's defective design, materials or workmanship.

The Supplier indemnifies PRASA against claims, proceedings, compensation and costs payable arising out of infringement by the Supplier of the rights of others, except an infringement which arose out of the use by the Supplier of things provided by PRASA.

#### **Assignment and sub-contracting**

The Supplier may not assign or subcontract any part of this order/contract without the written consent of PRASA.

#### **Termination**

PRASA may terminate the order/contract at any time (without prejudice to any right of action or remedy which has accrued or thereafter accrues to PRASA):

If the Supplier defaults in due performance of the order/contract, or if the Supplier becomes bankrupt or otherwise is, in the opinion of PRASA, in such financial circumstances as to prejudice the proper performance of the order/contract, or for any other reason in which case the Supplier will be compensated for all costs incurred.

#### **Governing law**

The order/contract is governed by the law of the Republic of South Africa and the parties hereby submit to the non-exclusive jurisdiction of the South African courts.

---

### **The Scope of Work and Areas of Focus:**

#### **The Scope of work is the following:**

- a. Provide a comprehensive support contract for PRASA CRES automated utility meters, water and electricity at Prasa Stations listed in Annexure C nationally, and related properties where the current meters have been installed.
- b. Monthly distribution of the bills (invoices), water and electricity.
- c. Pre-paid vending service in respect of pre-paid electricity and water meters.
- d. Reading and billing of conventional electricity meters (Park Station).
- e. Validation of all payments, prepaid sales and automated metering;
- f. Regular (monthly) confirmation of the correct billing tariffs as per the respective guidelines, procedures, by-laws and regulations from, and applied by the various service providers (e.g. City of Tshwane, Eskom and Rand Water).
- g. Provision of comprehensive monthly reporting to PRASA CRES per Station, Region, tenant, utility type and meter number; this includes:
  - Generation of the necessary invoicing as per PRASA's Real Estate Management Division's reporting formats.
  - Performance reporting per station, property and meter.
  - Revenue projections per station, per customer, inclusive of consumption statistics.
  - Provision of comprehensive monthly reporting to PRASA, per station and per utility meter.
- h. Regular meter audits and tariff adjustments.

#### **The areas of focus are described below:**

- Automated meter reading and billing;
- Provision of prepaid vending facilities and services;
- Billing of invoices on a monthly basis in respect of all credit electric and water meters;
- Technical support in respect of the meters and vending system;
- Monthly performance reporting per Station and meter.

## **Annexure B - Specifications**

---

### **Business Requirements:**

PRASA CRES has already commissioned automated electricity and water meters at various stations. It is imperative that at least the same data integrity on meter readings and reporting be achieved.

The minimum core requirements are:

- The system must support the appropriate metering technologies spanning a wide range of Original Equipment Manufacturers (OEM).
- Support of meter data management and vending for electrical power and water utilities across both STS and AML equipment (prepaid and online meters).
- The current information architecture and system integrity will not be compromised in any format; similar or better than the current service provider.
- The system will operate in the same, auditable online environment that is already integrated with existing and matured electronic and retail purchase and vending channels, including: Online Credit Card, Bank Cash Deposit and EFT, and retails Points of Sale such as BP, SASOL, SPAR, Pick 'n Pay, SHOPRITE, Seven Eleven, Caltex, ENGEN, TOTAL, etc.
- An end-to-end solution is required such that transactions and vending are reflected and completed in “real-time”, without batch processing, within a single relational database.
- End-to-end transparency is a pre-requirement, such that consumers are able to access the detail of their utility metering accounts and that authorized PRASA CRES staff must be able to access the system using any standard Web Browser within the PRASA ICT Architecture.
- Vendors/Service Providers are required to integrate fully with the current comprehensive service desk (e.g. telephonic and electronic) support to end consumers and the above authorized PRASA and PRASA CRES staff.
- Applicants must observe the current billing and metering management process being undertaken by an existing service provider and must indicate how it will interface/integrate with the current service provider.
- In all cases the current applicable ESKOM tariffs and Local Authorities' guidelines regarding the supply of water will apply.

## **Management System Requirements:**

PRASA is implementing the SAP ERP architecture and it is essential that the billing and lease management systems be eventually integrated into SAP Property Management. It is therefore essential that the applicants observe the initial system be upgradeable without architecture changes into the SAP Property Management module.

The integrity of the current management system and management system reporting will not be compromised in any way. The following system requirements are applicable:

- The system must be capable of remote-control functions such as remote reading, remote programming, remote diagnosis, remote disconnect and reconnect.
- The system must be capable of detecting various events and generating appropriate alerts.

- Provide monitoring to provide revenue protection and fraud detection with incident escalation.

## **Technical Requirements:**

- The metering systems and equipment required for shall comply with the already established utility management processes for electricity and water that covers:
  - Metering (management of changes) process
  - Customer Contracts amend procedures
  - Application guidelines for Pre-paid and Post-Paid Meters
  - Meter reading and audit processes
