## **SECTION 3 : RFI SCOPE OF REQUIREMENTS**

### **1 INTRODUCTION**

TNPA is requesting information to enquire whether there are existing designed helicopters which is in operation currently, or sold similar helicopter before in the past that meets our specification.

The helicopters must conform to the detailed specifications attached as Annexure A and Annexure B specification:

### **2 BACKGROUND**

Transnet's intention through this RFI is to determine the availability of suitable goods/services in the market place, to formulate a market analysis. Your submission should provide a response that is 100% in compliance to the scope of requirements stipulated under section 1, introduction above, and this has to be duly provided on the form provided in section 3 of this RFI. The information provided will be used to determine what is available in the market.

### **3 KEY OBJECTIVES OF THIS RFI PROCESS**

The following list of deliverables captures the minimum intent and objectives of the RFI process. Transnet requests all Respondents to assist with the achievement of these objectives by submitting the requested information as indicated below:

- 3.1 The respondents must indicate whether they have capacity to manufacture, supply and deliver the helicopters in accordance with the scope of requirements stipulated under section 1 herein RFI;
- 3.2 The respondents must indicate whether they have any helicopters that meets the specification outlined in section 1 herein RFI, currently already designed and are operational;
- 3.3 The respondents must indicate whether they have previously or currently have manufactured, supplied and delivered helicopters herein referred to before; and
- 3.4 The respondents must indicate turnaround period for manufacturing, supply and delivery of the helicopters herein referred to.

### **4 GENERAL RESPONDENT OBLIGATIONS**

- 4.1 The Respondent(s) shall be fully responsible to Transnet for the acts and omissions of persons directly or indirectly employed by them.
- 4.2 The Respondent (s) must comply with the requirements stated in this RFI.

### **5 CONFIDENTIALITY AND COMPLIANCE**

This RFI and information contained herein or provided for purposes thereof, remain the property of Transnet and may not be reproduced, sold or otherwise disposed of.
