PURPOSE

Johannesburg Tourism Company (JTC) seeks quotations from accredited and experienced training service providers for the provision of a two (2) days training in-person training for Supply Chain Management Stakeholder Relationship Management. The targeted number of officials to be trained is twenty-six (26) officials. The identification of all key stakeholders and the manner in which relationships should be managed in the procurement process is the focal point of the required training.

OBJECTIVE

The objective of these terms of reference is to appoint a qualified, experienced and accredited training provider to offer face-to-face training for SCM Practitioners and end users as per the scope of services outlined hereto below.

SCOPE OF SERVICES

The scope of the services is as follows:

- The nature of the buyer / supplier relationship and the skills required to manage supplier relationships effectively
- Various supply models for evaluating the required relationship with a particular supplier depending on the supply relationship, your organisation's product and service offering, the level of competition and collaboration in the relationship and the impact of stakeholder requirements on the purchasing decision
- The role and importance of strategic supplier relationship management (SRM) with international suppliers
- The SRM team's responsibilities and review a list of key responsibilities
- The cross-functional team's involvement in SRM and identify the roles of seven different disciplines in this process
- The different management practices of implementing SRM.
- Which SRM practices should be avoided during the term of a contract?
- The different contract types associated with the different positions on the buyer/supplier continuum

EXPECTED OUTCOMES AND DELIVERABLES

The expected outcomes and deliverables must be read in conjunction to the scope of work/services and should take into cognisance that real and perceived outcomes of navigating the delicate relationship between the client, supplier and other relevant stakeholders, primarily the identification of common blind spots that officials should look out for in the management of the relationships.

7.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
