1. PURPOSE

The purpose of this exercise is to appoint a legible contractor for alterations to the office and youth centre in Harkerville, Knysna section of the Garden Route National Park as specified on the scope of work.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORKS

Removal of wall in office

- Remove wall in office to create open space for reception area.
- Plaster both walls where bricks were removed to create even surface.
- Paint whole reception area Lowsheen Eggshell white

Youth centre

- Construct dry wall consisting of 114 CCA or equivalent treated pine.
- Cover with 19mm plywood and Themo isolation in between.
- Install a ceiling, construct using 40 x 40mm threaded CCA- treated brandings. Use 6mm of nutec board with Themo isolation inside
- Remove existing sink and re-install on the entrance wall at Youth Centre, complete with sink outlets, taps and waste pipes.
- Remove the window completely and install smaller window and door.
- Remove shiplap planks and replace with nutec handy planks on front wall.
- Round off with corner strips.
- Construct wooden deck in front of the office entrance. 105mm x 20mm thickness
- Install kitchen cupboard complete with sink bowl, tap mixer, water supply and waste pipes in boardroom

- Operators must always wear protective clothing including safety harnesses and hard hats whenever working on heights.
- Service Provider holds full responsibility for the safety of his/her workers.
- Service Provider must have his/her own tools and transport while on site.
- All building rubble to be remove from site daily by contractor.

6. TIMELINES

The period of the contract is 21 days. SANParks reserves the right to cancel the Purchase Order should the contractor fail to perform as per the contract.

11. EVALUATION FORMULA FOR PRICE

The following formula will be applied to calculate the scores:

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

Ps = Points scored for price of the bid under consideration.

Pt = Rand value of bid under consideration.

Pmin = Rand value of lowest acceptable bid

12. FINAL AWARD

Bidder who complies with the specifications and scores highest total points on PRICE and B-BBEE claimed points shall be awarded the contract. SANParks reserves the right to:

- Award the contract in full or partially
- Award to more than one bidder, and/or
- Not to award
- Re-advertise should the minimum of three written quotations not be received
- Not to award to the bidder scoring the highest points
- Not to award to bidders who have previously failed to deliver/ provided poor work.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary
