1. BACKGROUND

The project was identified in relation to the city's obligation to provide aid in the aftermath of various emergency incidents or disasters caused by natural causes, such as fires, floods etc. Social relief of distress is a temporary form of assistance intended to help individuals who are in dire material need and unable to meet their own or their family's most basic needs.

The aim of the project is to provide emergency relief to the community of the City of Tshwane during or after emergency incidents or disasters. The purchased items will be utilized throughout the City of Tshwane. The delivery of the items may be requested to be made anywhere within the borders of the City of Tshwane. The relief items will be delivered by the service providers as and when required. These items will be stored in a centralized storeroom in the Emergency Services Department for control and monitoring before distribution to affected communities.

2. PROJECT SCOPE

It is the intent of the City of Tshwane that these specifications cover the supply and delivery of disaster relief items on an as and when required basis for a period of twelve (12) months.

With a view of obtaining the best results and the most acceptable product for service in the Emergency Services Department, these specifications cover only the general requirements. Minor details of materials where not otherwise specified are left to the discretion of the bidder.

All products, equipment and accessories shall be new and of the highest quality. They

shall be protected from damage; any damaged, flawed or defaced materials shall be rejected and replaced at a cost by the service provider.

The bidder shall further warrant that all materials / goods supplied under tender award shall have no defect, arising from design, materials, or workmanship or from any act or omission of the supplier that may develop under normal use of the supplied goods in the conditions prevailing in the country of destination.

Tenderers are required to provide laborers and equipment for the off-loading of the ordered items.

To eliminate divided responsibility and service, the full scope, which includes the supply, delivery of disaster relief items **will be adjudicated to one bidder**. The service providers shall remain responsible for the warranty of the products on offer.

3. DELIVERABLES

 - Pegs Hammer
 - Bracing ropes
- b) 3m x 3m ground sheet

ITEM 5: DISASTER EMERGENCY RELIEF TENT

Must comply with the following minimum requirements:

- Tent: Cottage style
- Size: 3m x 3m (Minimum)
- Height: 1.8m (Minimum)
- Material: HDPE Polypropylene.
- The tent must include pegs, poles, ropes, and sidewalls as well as an integrated ground sheet.
- The ground sheet must be attached as part of the tent
- Each tent must be delivered individually in a packaging including all parts in one unit (tent bag or similar)

ITEM 6: FLOOD PROTECTION SANDBAGS



6. VALIDITY PERIOD

The validity period for the tender after closure is 90 days. CoT shall have right and power to extent any tender validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalised while the quotations/bids are still valid.

7. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be disqualified based on being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
