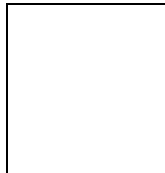

## 1. BANKSETA'S BACKGROUND

The Banking Sector Education and Training Authority (BANKSETA) is the SETA for the banking and alternative banking industry. It is a statutory body established through the Skills Development Act of 1998 as amended by the Skills Development Act, 26 of 2011 to enable its stakeholders to advance the national and global position of the banking and alternative banking sector. As guided by its mandate, the BANKSETA aims at transformation and seeks to promote employment equity and broad-based BEE through skills development.

## 2. PURPOSE AND OBJECTIVES OF THE PROJECT

- 2.1 The BANKSETA is seeking to appoint an accredited training provider in South Africa to provide training services for a learnership initiative, namely Sector Learnerships for 250 learners nationally.
- 2.2 The purpose is to offer unemployed youth the opportunity to gain a qualification and one year's work experience in the sector, making them more employable upon completion. This is a legacy qualification and as a result, it will be implemented over a one year period.

## 3. SCOPE OF WORK

- 3.1 The program requires a standardised curriculum consisting of the following as specified in the qualification (**National Certificate Business Analysis. This qualification is registered at NQF level 6, SAQA ID 63909, these are the minimum learning outcomes that must be included**)
  - 3.1.1 Analyse a Business Scenario
  - 3.1.2 Develop a Business Case
  - 3.1.3 Compile User Requirements Specifications
  - 3.1.4 Develop Functional Specs
  - 3.1.5 Monitor quality assurance (QA) activities through the Project Lifecycle
- 3.2 In addition, the provider must be able to cover the following topics:
  - 3.2.1 Introduction to data science approach or methodology,
  - 3.2.2 Understanding of distributed processing and analytics as well as different ways to consume data.
  - 3.2.3 Data warehousing, data mining and predictive analysis.

- 3.2.4 R programming (is an advanced language that performs various complex statistical computations and calculations)
- 3.2.5 Excel training
- 3.2.6 An introductory module to info security or data privacy
- 3.2.7 Artificial intelligence
- 3.2.8 Tools: power Business Intelligence (BI) and Tensorflow

3.3 The service provider should provide training for learnership and be able to do the following;

- 3.3.1 The provider will submit a comprehensive overall training course plan and program.
- 3.3.2 Provide a brief outline of the schedule for the learning program, including specific outcomes for each module and details of the material.
- 3.3.3 Provide the learners with the approved schedule on the first day of the academic induction.
- 3.3.4 The provider needs to provide learner support. Learner support refers to mentoring and coaching learners about the theoretical component of the learnership.
- 3.3.5 Assess the learners against the outcome of the qualification and make provision for one re-assessment opportunity should the learner still need to be competent.
- 3.3.6 The provider needs to provide guidelines, for example, a toolkit for the mentors/coaches for the organisations to enable them to support the learners with projects/assignments in the workplace.
- 3.3.7 The provider will be responsible for all costs and logistic arrangements regarding the graduation ceremony and Certification.
- 3.3.8 The provider will be responsible for collating all learner documents, including signing learner agreements as required for learnerships.
- 3.3.9 The provider is required to meet all the SETA reporting and audit requirements, including but not limited to the DHET report and internal and external audit requirements.
- 3.3.10 The provider must know all applicable legislation governing the workplace-based learning process.
- 3.3.11 The service provider must be able to attend monthly meetings and be available to meet on an ad-hoc basis should the need arise. These meetings will be held online.
- 3.3.12 The service provider must adhere to the BANKSETA program timeline and meet BANKSETA deadlines.
- 3.3.13 Provide a comprehensive close-out report including statistics on learner completions and lessons learned.
- 3.3.14 The provider must advise the SETA immediately of any learner contract terminations and the reasons thereof

- 3.3.15 The provider must monitor the learner attendance of training and learning progress and report to the SETA monthly (this will include attendance registers and assessment results).`

#### **4. COMPETENCY AND EXPERTISE REQUIREMENTS**

4.1 The service provider should be able to:

- 4.1.1 Provide proof of accreditation as an education and training provider with the relevant Quality Council. The accreditation status must include **National Certificate in Business Analysis. This qualification is registered at NQF level 6, SAQA ID 63909**. The accreditation must be valid at the tender's closing and for the period of the contract or be renewable to cover the period of the contract.
- 4.1.2 Provide signed references on the client's letterhead of successfully completed project(s) for learnership implementation within the past five (05) years (from closing date of this tender.)
- 4.1.3 The service provider should provide relevant team experience with applicable qualifications.
- 4.1.4 The service provider should provide a Project plan.
- 4.1.5 Meet the required Quality Requirements, proof that the programme meets Quality Assurance Requirements, reporting to the SETA and stakeholders.
- 4.1.6 The service provider should provide a learner support which include;
  - 4.1.6.1 Interview each learner everything month in the workplace or training to identify potential issues that may prevent the learner from completing the programme
  - 4.1.6.2 Liaising with employers and other stakeholders to manage and track learner progress,
  - 4.1.6.3 Learner relationship and conflict management, and
  - 4.1.6.4 Provide a minimum of 3 days' work readiness training (Exit Programme)

#### **5. DURATION OF THE CONTRACT.**

- 5.1 The contract will be valid for a period of 18 months of which 12 months will be the implementation of the Programme/Training. The implementation of the programme training will be from 1 February 2024.

## 6. PRICING STRUCTURE

***N.B: The Pricing Schedule must be completed as per the attached annexure A. Bidders who fail to comply with this requirement will be disqualified because it will be impractical to compare pricing across all submissions.***

- 6.1 The quoted prices will remain fixed for the entire duration of the contract.
- 6.2 The attached pricing sheets (Appendix A) should be completed in full. The BANKSETA will not entertain pricing adjustments after the signing of contract, and it is therefore important that all pricing elements are disclosed.
- 6.3 The pricing sheet should show VAT separately.
- 6.5 Sufficient detail should be included to enable the BANKSETA to fully understand the make-up of the overall pricing.
- 6.6 All pricing assumptions, excluded costs and estimated costs should be clearly documented. The BANKSETA assumes that the pricing document as supplied is complete and covers all costs associated with this project.

- 7.2 Respondents should take particular care to ensure that there is no discrepancies between all submissions presented to the BANKSETA.

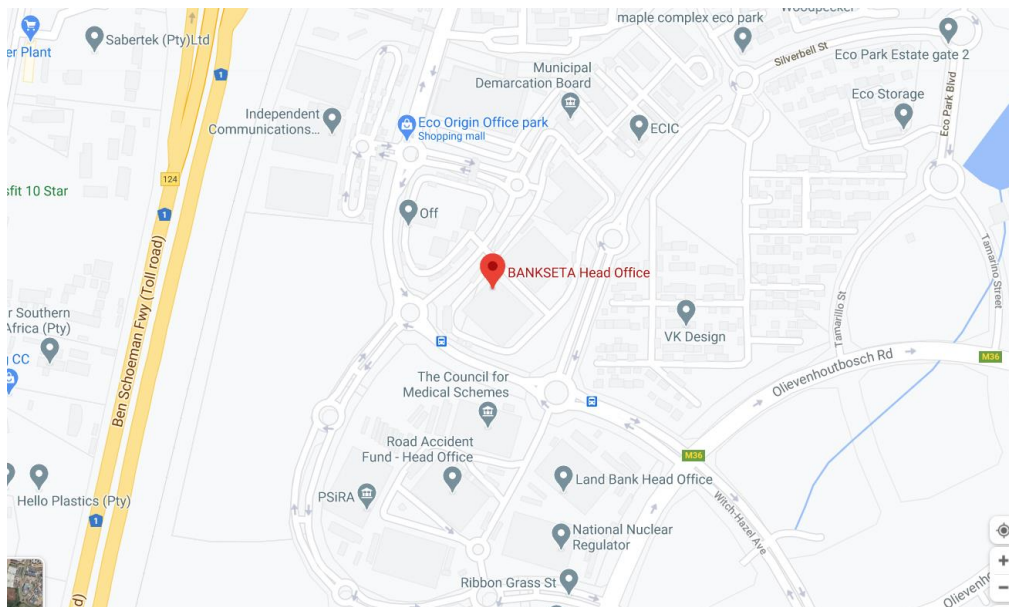

## 9. TENDER EVALUATION/ADJUDICATION

Bids will be evaluated in three phases:

- 9.1 Compliance/eligibility evaluation (Bids that do not pass the compliance eligibility evaluation will be disqualified from participating in the next evaluation stage),
- 9.2 Technical/Functionality evaluation (Bids that do not meet the minimum threshold indicated in clause 12 will not participate in the final evaluation of price and BBEE), and
- 9.3 Price and BBEE points evaluation. (Bidder will be appointed on the highest scores)

## 10. COMPLIANCE STATUS

- 10.1 The service provider should be registered on the Central Supplier Database (CSD) maintained by the National Treasury and accessible on [www.treasury.gov.za](http://www.treasury.gov.za)
- 10.2 The BANKSETA, before making an award, shall check on the central supplier database (CSD) whether;
  - (a) the bidder or any of its directors are not listed / indicated as restricted from doing business with the public sector, and/or are person(s) prohibited,
  - (b) the bidder's tax status is compliant.
  - (c) the bidders, its directors or management are not employees of the state, or if a director/manager is an employee of the state, the service provider and or directors/management have permission to do business with the state, as provided for in the legislation.
- 10.3 The BANKSETA will not award any bids to service providers who do not comply with the above.
- 10.4 The BANKSETA will afford bidders a chance to clarify and provide evidence where there is any adverse information on the CSD reports.

The minimum weighting threshold for technical / functional evaluation is 70%. Any bidder scoring less than 70% or 70 weight will be disqualified from further evaluation.

**13. Functionality will be evaluated using the following formula for each criterion or sub-criterion.**

$$Pf = (So/Ms) \times Ap$$

Where:

- Pf – is the percentage/weighting scored for functionality for that criterion or sub-criterion under consideration.
- So – is the total score evaluated by the BANKSETA for the criterion or sub-criterion under consideration.
- Ap – is the percentage allocated for functionality for the criterion or sub-criterion.
- Ms – is the maximum score possible per criterion or sub-criteria which is 5.

- 13.1 Each technical /functional evaluation criterion or sub-criterion shows how it will be evaluated by BANKSETA out of a maximum of 5 points. i.e Ms =5 points.
- 13.2 The score/points evaluated per criterion or sub-criterion by BANKSETA is divided by 5 and then multiplied by the weighting of the criteria to arrive at the percentage for that criterion/sub-criterion.
- 13.3 The percentages for all criteria/sub-criteria are added together to reach the final percentage or weighting.
- 13.4 Any proposals not meeting a minimum total weight threshold of 70 **percentage** or 70 weighting on functionality/technical evaluation will not participate in the price/preference points evaluation.

## 14. PRICE AND PREFERENCE POINTS EVALUATION

The tender will be evaluated using the following:

### 80/20 PRICE/PREFERENCE POINT SYSTEMS

## **EXPLANATIONS**

- 14.2 Black persons are as defined in Broad based black economic empowerment Act (B-BBEE) which currently means Africans, Coloureds, and Indians:
- (a) who are citizens of the Republic of South Africa by birth or decent; or
  - (b) who became citizens of the Republic of South Africa by naturalisation –
    - (i) before 27 April 1994;
    - (ii) on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisation prior to that date.
- 14.3 Black Person Ownership points will be awarded to a Tenderer who have 51% or more black ownership. The shareholding will determine the ownership.
- 14.4 Promotion of Local Production and Services Delivered by South Africans
- The goods supplied should be 100% manufactured or assembled in South Africa from 100% local materials and any services supplied should 100% utilising South African citizens. Should the work be only services, the services should be supplied 100% utilising South African citizens.
- 14.5 Women ownership points will be awarded to a Tenderer who have 50% or more women ownership are South African citizens.
- 14.6 Youth ownership points will be awarded to a Tenderer who have 33% or more youth ownership being persons 35 years and below, determined at the date of tender/ RFQ closing.
