PART 1: INVITATION TO TENDER

1 GENERAL

Submissions to this Request for Proposal (RFP) [hereinafter referred to as a Tender or a Proposal] are requested from persons, companies, close corporations or enterprises [hereinafter referred to as an entity, or Tenderer].

1.1 DESCRIPTION

RFP number SFF/2024/NOE/SP6 FOR THE APPOINTMENT OF A SERVICE PROVIDER TO CARRY OUT TECHNO-COMMERCIAL ANALYSIS AND FEASIBILITY STUDIES FOR MULTIPLE OPTIONS TO ACQUIRE NEW GEOTECHNICAL DATA FROM KEDELAI #1 WELL IN BLOCK B2, JONGLEI SUB BASIN, SOUTH SUDAN BY RE-ENTRY /SIDETRACKING OR DRILLING A NEW WELL (SUBPROJECT# 6).

Any additional information or clarification will be uploaded on the SFF website and the National Treasury e-tender publication portal.

3 **BROAD-BASED BLACK ECONOMIC EMPOWERMENT AND SOCIO-ECONOMIC OBLIGATIONS**

SFF Association fully endorses and supports the Government's objective of Broad-Based Black Economic Empowerment and it is strongly of the opinion that all South African business enterprises have an equal obligation to redress the imbalances of the past.

3.1 B-BBEE Joint Ventures or Consortiums

Tenderers who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Tenderers must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If such a JV or consortium agreement is unavailable, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by SFF association through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to SFF Association.

3.2 Preference Points and Specific Goals

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and Preferential Procurement Regulations 2022, Tenderers are to note that the following preference point systems:

- **the 80/20 system for requirements with a Rand value of up to R50,000,000 (all applicable taxes included) OR**
- **the 90/10 system for requirements with a Rand value above R50,000,000 (all applicable taxes included)**

When SFF association invites prospective Service Providers to submit Proposals for its Specific Goals, it requires Tenderers to complete Annexure A [the B-BBEE Preference Point Claim Form] and submit it together with proof of their documents as stipulated in the Claim Form in order to obtain Specific Goal Points.

Note: Failure to submit a valid and certified copy B-BBEE certificate or Sworn Affidavit or any other documents specified (as evidence for Specific Goals) at the Closing Date of this RFP will result in a score of zero being allocated for Specific Goals.

3.3 Subcontracting

SFF association fully endorses Government's transformation and empowerment objectives when contemplating subcontracting. Tenderers are requested to give preference to companies which are, Entities with a specified BEE level, EMEs and QSEs, and South African Owned Companies in order to promote Supplier Development.

In terms of Annexure A of this RFP [the B-BBEE Preference Point Claim Form], Tenderers are required to indicate the percentage of the contract that will be sub-contracted as well as the B-BBEE status of the sub-contractor/s.

In addition, tenderers are required to attach a letter from the intended sub-contractor in the event of the Tenderer's appointment.

- 5.3 Unless otherwise expressly stated, all proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.

6 COMPLIANCE

The successful Tenderer shall be in full and complete compliance with any and all applicable laws and regulations.

7 DISCLAIMERS

Tenderers are hereby advised that SFF is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that SFF reserves the right to:

- 7.1. modify the RFP's Scope of Work and request Tenderers to re-tender on any such changes;
- 7.2. reject any Proposal which does not conform to instructions and scope of work which are detailed herein;
- 7.3. disqualify Proposals submitted after the stated submission deadline [Closing Date];
- 7.4. not necessarily accept the lowest priced Proposal or an alternative Tender;
- 7.5. validate any information submitted by Tenderers in response to this tender. This would include but not limited to, requesting the Tenderer to provide supporting evidence. By submitting a tender, the Tenderer hereby irrevocable grant the necessary consent to SFF to do so;

9 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Tenderers are required to self-register on National Treasury's Central Supplier Database ("CSD") which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Tenderers must register on the CSD prior to submitting their bids. Business may not be awarded to a Tenderer who has failed to register on the CSD. **Only foreign suppliers with no local registered entity need not register on the CSD.**

For this purpose, the attached SBD1 form must be completed and submitted as a returnable document by the closing date and time of the bid (ANNEXURE E).

10 TAX COMPLIANCE

Tenderers must be compliant when submitting a proposal to SFF and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this tender that the tax matters of the successful Tenderer be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Tenderer's tax obligations.

The Tax Compliance status requirements are also applicable to foreign Tenderers who wish to submit tenders.

11 PROTECTION OF PERSONAL INFORMATION ACT, NO.4 OF 2013

SFF association acknowledges that the Tenderer may be required to process the personal information of SFF association and other relevant data subjects in connection with and for the purposes of this RFP.

The Tenderer shall–

- (a) only process such personal information for the purpose connected with this RFP, except to the extent specifically requested to do otherwise by SFF association in writing or required by the Protection of Personal Information Act, No.4 of 2013 (POPI) or other applicable laws;
- (b) comply with all directions and instructions which may be given by SFF association regarding the processing of such personal information;

PART 2. BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

12 BACKGROUND AND SCOPE OF WORK

12.1 Introduction

RFP number SFF/2024/NOE/SP6 is for a service provider, referred to as the Tenderer in this tender document, to carry out a feasibility study referred to as Sub-Project#6 in the licence Block B2 in South Sudan.

South Africa's state-owned Strategic Fuel Fund ("SFF") signed an Exploration and Production Sharing Agreement (EPSA) with the Ministry of Petroleum, South Sudan government, in May 2019. Under this agreement, SFF will carry out E&P activities in Block B2 in partnership with South Sudan's national oil company, Nile Petroleum Corporation.

As part of the exploration program, SFF carries out geological and geophysical studies in Block B2 to increase the chance of hydrocarbon discovery. In order to fulfil the obligation SFF intends to acquire well data in Block B2 to firm up geological and geophysical models. Before the data acquisition project execution, SFF is seeking a technically competent service provider to conduct a techno-commercial analysis and feasibility studies for multiple options to acquire new Geotechnical data from Kedelai - 1 well in Block B2, Jonglei Sub Basin, South Sudan by re-entry /sidetracking or drilling a new well.

12.2 Background Information

The well data acquisition will assist in defining stratigraphic correlations and understanding the geology of Jonglei Sub-basin. The results will be used to (a) improve the time depth relationships and velocity models, (b) classify reservoir characteristics, (c) validate elements and confirm the active petroleum system.

Geologically, the area of study (Jonglei Sub-basin) is located in the southern part of Muglad Basin, a large rift basin related to the Central African Rift Zone. Jonglei Sub-basin remains unexplored, and its geology and oil potential are vaguely understood; however, it is expected to be the extension of the main Muglad Basin.

12.3 Objectives

To provide comprehensive techno-commercial analysis with reasoning and analysis, including site visit, to acquire new geotechnical data by either of methods of re-entry up to present TD /sidetracking to new TD or drilling a new well with new TD and summarise its financial implications with cost-benefit analysis.

Post-decision, the feasibility study is to be designed with the goal of achieving the following dependent on the chosen option.

- To collect cuttings and or sidewall cores for biostratigraphy, sedimentology and geochemical studies
- To collect wireline logs (or LWD) as per the programme to conduct G&G studies. Logs to be acquired are, not limited to: GR, Resistivity, density, neutron, calliper, sonic Vp & Vs, fluid analysis, formation test RFT, Gas log, etc.
- To collect formation pore fluid data and determine GWC and Sw from hydrocarbons detected while drilling, wireline logs and drill string testing.
- To acquire checkshot data for well seismic tie and velocity modelling/ time-depth conversion.

12.4 Scope of Study

Aspects related to defining the feasibility study to acquire well data in Block B2, South Sudan include but are not limited to:

- Conduct a physical inspection of the well site and the approachability.
- Identify potential technical, operational, and economic risks associated with the operations.
- Evaluate alternative scenarios, such as different re-entry techniques, sidetracks, new drills, etc.

13 PROJECT EXECUTION PLAN

Tenderer must submit a description of planned project activities including a Project Execution Plan (PEP), which will provide details of the specific activities in the project, the resources applied to the project, and the organization of the project. The major elements of a project execution plan are:

- Scope Definition
- Project scheduling
- Timelines as per deliverables (Milestones)
- Resource allocation

14 PROJECT DESCRIPTION




Figure 2 Physiographic map showing location map of Kedelai-1 well and legacy seismic lines in Block B2, South Sudan

Licence Block B2 is located in the south-eastern portion of South Sudan and extends over an area of approximately 48,000 sq-km. The Area of interest (AOI) terrain is mainly flat and subjected to seasonal flooding of the White Nile River. It consists of swamps (20%) and floodplains (80%) figure1. Kedelai-1 well was drilled in Block B2, Onshore South Sudan in 2007. The well location is 200km North of Juba in Jonglei State (Figure 1 and 2). The well was situated in the White Nile floodplain in an area known as the Sudd - one of the world's most expansive and important wetlands and an environmentally sensitive area. The natural surface soil is 'Black Cotton', a clay that is rock hard when dry but very unstable when wet.

Kedelai well was partly drilled to the depth of 2408m and did not intersect the targeted reservoir. The minimum essential well data for geological and geophysical studies was not acquired before the well was suspended. The well was suspended due to hole conditions and increasing adverse weather conditions. It was suspended with the intention of resuming drilling activities at the onset of the dry season. However, the plan was unfortunately not implemented.




Figure 3 Kedelai well schematic

While pulling out of the hole to suspend the well, the string became stuck at the stabiliser with the bit at 2,200m. Attempts to jar free were unsuccessful, and the string was backed off at this point, leaving 23.24m of BHA in the hole. The well was then suspended by setting two plugs, each 150m long, above the fish, two plugs across the 9 5/8" casing shoe and one just below the surface. This provides the well with two mechanical barriers between the open hole and surface and enough cement plug to allow a sidetrack well to be drilled at a later date if so required. Figure 3 is the Kedelai well schematic diagram.

The available data from the well encompasses a partial gamma-ray log from 88 to 1127 meters and well cuttings from the surface to the total depth. Moreover, biostratigraphy and sedimentological studies have been conducted based on these well cuttings. Unfortunately, the results of these studies are inconclusive, as drill bits with tungsten-carbide inserts and a diamond bit used during drilling may have caused the claystone/shales to grind down, leading to mud dispersal and loss of washed cuttings. Consequently, geological correlations (age, structural framework) between the Jonglei sub-basin and the main Muglad basin are not consistent.




Figure 4 Seismic line passing through Kedelai well location

2D seismic data is available in the block, and one line crosses the existing well location, as shown in Figures 2 and 4. Unfortunately, checkshots, VSP or sonic data are not available; therefore, conducting seismic tie and time-depth relationship models is problematic. As a result, calibrating seismic data to depth has a high level of uncertainty.

Given the limited legacy data, SFF has deemed it necessary to acquire more conclusive well data to augment the ongoing geological studies of the Jonglei Sub-basin. Different scenarios are to be explored to execute data acquisition. The final decisions will be made based on technical and economic feasibility. Below are three scenarios that are described, but not limited to.

Scenario 1: well re-entry and logging in the existing borehole

The objective is to re-enter the existing well, drill out cement plugs and acquire data up to drilled depth as per plan. Refer to figure 2 for the well schematic. Once all the logs are acquired, the well will be suspended after putting the suspension plug.

Scenario 2: Well re-entry, extend TD and logging

SFF intends to re-enter and deepen the depth of the well by an additional 800-1500m to intersect the reservoir. The operation can be achieved by either sidetracking or drilling out the fish that was left in the hole. Data acquisition will be conducted as per the program. If hydrocarbons are discovered, the well may be tested to determine the volume, quality, and type of hydrocarbons. After

completion of all the tests and data acquisitions, a well will be suspended following internationally recommended standards.

Scenario 3: New well drilling and logging full suite of data

On the other hand, if well re-entry is not feasible, then SFF intends to drill a new well to achieve the set objectives. Final drilling site selection will be based on further analysis of available data. The well will be drilled to approximately a depth of 3400 - 4000m to intersect both primary and secondary targets (Bentiu and AbuGabra formations).

TD of the well will depend on the presence of hydrocarbons in the primary target Formation. In case of a discovery, the well may be tested to determine the volume, quality, and type of hydrocarbons and TD of the well will be decided accordingly.

Upon completion of all the test and data acquisitions, the decision about the well will be taken based on internationally recommended standards.

APPENDIX (III): SAFETY ARRANGEMENTS AND PROCEDURAL COMPLIANCE WITH THE OCCUPATIONAL HEALTH AND SAFETY ACT (ACT 85 OF 1993) AND APPLICABLE REGULATIONS

1. General

- 1.1 The Contractor and SFF (hereinafter referred to as “the Client”) are individual employers, each in its own right, with their respective duties and obligations set out in the Occupational Health and Safety Act, Act 85 of 1993 (the Act) and applicable Regulations.
- 1.2 The Contractor accepts, in terms of the General Conditions of Contract and in terms of the Act, his obligations as an employer in respect of all persons in his employ, other persons on the premises or the Site or place of work or on the work to be executed by him, and under his control. He shall, before commencement with the execution of the contract work, comply with the provisions set out in the Act, and shall implement and maintain a Health and Safety Plan as described in the Construction Regulations, 2003 and as approved by SFF, on the Site and place of work for the duration of the Contract.
- 1.3 The Contractor accepts his obligation to complying fully with the Act and applicable Regulations notwithstanding the omission of some of the provisions of the Act and the Regulations from this document.
- 1.4 SFF accepts, in terms of the Act, its obligations as an employer of its own employees working on or associated with the site or place of work, and the Contractor and Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall at all times, co-operate in respect of the health and safety management of the site, and shall agree on the practical arrangements and procedures to be implemented and maintained during execution of the Works.
- 1.5 In the event of any discrepancies between any legislation and this specification, the applicable legislation will take precedence.

2. Definitions

- 2.1 In this Specification any word or expression to which a meaning has been assigned in the Construction Regulations, shall have the meaning so assigned to it, unless the context otherwise indicates: -
- 2.2 **“competent person”** in relation to construction work, means any person having the knowledge, training and experience specific to the work or task being performed:
Provided that where appropriate qualifications and training are registered as per the South African Qualifications Authority Act, 1995 these qualifications and training shall be deemed to be the required qualifications and training;
- 2.4 **“contractor”** means principal contractor and **“subcontractor”** means contractor as defined by the Construction Regulations, 2003.
- 2.5 **“fall protection plan”** means a documented plan, of all risks relating to working from an elevated position, considering the nature of work undertaken, and setting out the procedures and methods applied to eliminate the risk;
- 2.6 **“health and safety file”** means a file or other record in permanent form, containing the information required to be kept on site in accordance with the Act and applicable Regulations;

- 2.7 **“Health and Safety Plan”** means a documented plan which addresses the hazards identified and include safe work procedures to mitigate, reduce or control the hazards identified;
- 2.8 **“Risk Assessment”** means a programme to determine any risk associated with any hazard at a construction site, in order to identify the steps needed to be taken to remove, reduce or control such hazard;
- 2.9 **“the Act”** means the Occupational Health and Safety Act No. 85 of 1993.
3. The Contractor shall, in accordance with the Act and applicable Regulations, make all the necessary appointments of competent persons in writing on a form similar to Annexure 2 of this Specification and deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager. Copies should also be retained on the health and safety file.
- 3.1 Subcontractors shall also make the above written appointments and the Contractor shall deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager.
- 3.2 In the case of a self-employed Contractor or any subcontractor who has the appropriate competencies and supervises the work himself, the appointment of a construction supervisor in terms of regulation 6.1 of the Construction Regulations, 2003 will not be necessary. The Contractor shall in such a case execute and sign a declaration, as in Annexure 3, by which he personally undertakes the duties and obligations of the "Chief Executive Officer" in terms of section 16(1) of the Act.
- 3.3 The Contractor shall, before commencing any work, obtain from the Procurement Manager / SHEQ Manager / Technical Manager an access certificate as in Annexure 4 executed and signed by him, permitting and limiting access to the designated site or place of work by the Contractor and any subcontractors under his control.
- 3.4 Procedural compliance with Act and Regulations, as above, shall also apply to any subcontractors as employers in their own right. The Contractor shall furnish the Procurement Manager / SHEQ Manager / Technical Manager with full particulars of such subcontractors and shall ensure that they comply with the Act and Regulations and safety requirements and procedures.
- 4. Special Permits**
- Where special permits are required before work may be carried out such as for hot work, isolation permits, work permits and occupations, the Contractor shall apply to the Procurement Manager / SHEQ Manager / Technical Manager or the relevant authority for such permits to be issued. The Contractor shall strictly comply with the conditions and requirements pertaining to the issue of such permits.
- 5. Health and Safety Programme**
- 5.1 The Tenderer shall, with his tender, submit a Health and Safety Programme setting out the practical arrangements and procedures to be implemented by him to ensure compliance by him with the Act and Regulations and particularly in respect of: -
- (i) The provision, as far as is reasonably practical, of a working environment that is safe and without risk to the health of his employees and subcontractors in terms of section 8 of the Act;

- (ii) the execution of the contract work in such a manner as to ensure in terms of section 9 of the Act that persons other than those in the Contractor's employment, who may be directly affected by the contract work are not thereby exposed to hazards to their health and safety;
 - (iv) ensuring, as far as is reasonably practical, in terms of section 37 of the Act that no employee or subcontractor of the Contractor does or omits to do any act which would be an offence for the Contractor to do or omit to do.
- 5.2 The Contractor's Health and Safety Programme shall be based on a risk assessment in respect of the hazards to health and safety of his employees and other persons under his control that are associated with or directly affected by the Contractor's activities in performing the contract work and shall establish precautionary measures as are reasonable and practical in protecting the safety and health of such employees and persons.
- 5.3 The Contractor shall cause a risk assessment contemplated in clause 5.2 above to be performed by a competent person, appointed in writing, before commencement of any **Construction Work** and reviewed during construction. The Risk Assessments shall form part of the Health and Safety programme to be applied on the site and shall include at least the following:
- The identification of the risks and hazards that persons may be exposed to;
 - the analysis and evaluation of the hazards identified;
 - a documented Health and Safety Plan, including safe work procedures to mitigate, reduce or control the risks identified;
 - a monitoring and review plan.
- 5.4 The Health and Safety Plan shall include full particulars in respect of: -
- The safety management structure to be instituted on site or place of work and the names of the Contractor's health and safety representatives and members of safety committees where applicable;
 - the safe working methods and procedures to be implemented to ensure the work is performed in compliance with the Act and Regulations;
 - the safety equipment, devices and clothing to be made available by the Contractor to his employees;
 - the site access control measures pertaining to health and safety to be implemented;
 - The introduction of control measures for ensuring that the Safety Plan is maintained and monitored for the duration of the Contract.
- 5.5 The Health and Safety programme shall be subject to the Procurement Manager / SHEQ Manager / Technical Manager's approval and he may, in consultation with the Contractor, order that additional and/or supplementary practical arrangements and procedures be implemented and maintained by the Contractor or that different working methods or safety equipment be used or safety clothes be issued which, in the Procurement Manager / SHEQ Manager / Technical Manager's opinion, are necessary to ensure full compliance by the Contractor with his obligations as an employer in terms

of the Act and Regulations. The Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall be allowed to attend meetings of the Contractor's safety committee as an observer.

- 5.6 The Contractor shall take reasonable steps to ensure that each subcontractor's Health and Safety Plan is implemented and maintained on the construction site: Provided that the steps taken shall include periodic audits at intervals mutually agreed to between the them, but at least once every month.
- 5.7 The Contractor shall stop any subcontractor from executing any construction work, which is not in accordance with the Contractor's, and/or subcontractor's Health and Safety Plan for the site or which poses a threat to the health and safety of persons.
- 5.8 The Contractor shall ensure that a copy of the Health and Safety Plan is available on site for inspection by an inspector, Procurement Manager / SHEQ Manager / Technical Manager, agent, subcontractor, employee, registered employee organization, health and safety representative or any member of the health and safety committee.
- 5.9 The Contractor shall consult with the health and safety committee or, if no health and safety committee exists, with a representative group of employees, on the development, monitoring and review of the Risk Assessment.
- 5.10 The Contractor shall ensure that all employees under his control are informed, instructed and trained by a competent person regarding any hazard and the related work procedures before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.11 The Contractor shall ensure that all subcontractors are informed regarding any hazard as stipulated in the Risk Assessment before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.12 The Contractor shall ensure that all visitors to a construction site undergoes health and safety induction pertaining to the hazards prevalent on the site and shall be provided with the necessary personal protective equipment.

6. Fall Protection Plan

- 6.1 In the event of the risk and hazard identification, as required in terms of clause 5.3 of this Specification, revealing risks relating to working from an elevated position the contractor shall cause the designation of a competent person, responsible for the preparation of a fall protection plan;
- 6.2 The Contractor shall implement, maintain and monitor the fall protection plan for the duration of Contract. The Contractor shall also take such steps to ensure the continued adherence to the fall protection plan.
- 6.3 The fall protection plan shall include: -
 - A Risk Assessment of all work carried out from an elevated position;
 - The procedures and methods to address all the identified risks per location;
 - The evaluation of the employees' physical and psychological fitness necessary to work at elevated positions;

- The training of employees working from elevated positions; and
- The procedure addressing the inspection, testing and maintenance of all fall protection equipment.

7. Hazards and Potential Hazardous Situations

The Contractor and the Procurement Manager / SHEQ Manager / Technical Manager shall immediately notify one another of any hazardous or potentially hazardous situations which may arise during performance of the Contract by the Contractor or any subcontractor and, in particular, of such hazards as may be caused by the design, execution and/or location and any other aspect pertaining to the contract work.

8. Health and Safety File

- 8.1 The Contractor shall ensure that a health and safety file is opened and kept on site and shall include all documentation required as per the Act and applicable regulations, and made available to an inspector, the Procurement Manager / SHEQ Manager / Technical Manager, or subcontractor upon request.
- 8.2 The Contractor shall ensure that a copy of the both his Health and Safety Plan as well as any subcontractor's Health and Safety Plan is available on request to an employee, inspector, contractor or the Procurement Manager / SHEQ Manager / Technical Manager.
- 8.3 The Contractor shall hand over a consolidated health and safety file to the Procurement Manager / SHEQ Manager / Technical Manager upon completion of the **Works** and shall in addition to documentation mentioned in the Act and applicable Regulations include a record of all drawings, designs, materials used and other similar information concerning the completed structure.

HSE philosophy

Inherent safety and protection of the environment is a prerequisite from the beginning of the design process. The HSE philosophy must be included in the design premise document, and should include considerations on waste reduction, minimisation of fugitive emissions, ground water pollution prevention, minimisation of manning levels for hazardous processes, hazardous materials handling, early detection systems and specific measures to reduce risks to ALARP levels.

Hazard identification study

A systematic evaluation of all hazards shall be performed in the hazard study. The hazard study is the basis for the area classification drawings and may alter the location of for example buildings, process units on the plot plan or may lead to additional preventive measures (firewalls, other material types etc) being required.
