The Coega Development Corporation (CDC) is headquartered in the City of Gqeberha, Nelson Mandela Bay Municipality, South Africa, with a strategic operational footprint in South Africa and beyond the borders in the African continent. The CDC's vision is to be the leading catalyst for the championing of socio-economic development. This it seeks to achieve through the development and operation of the 9 003-hectare Coega Special Economic Zone (SEZ), a transshipment hub and a leading investment destination in Africa, providing highly skilled competence and capacity for the execution of quality complex infrastructure and related projects throughout South Africa and selected markets on the African continent, and advisory on the development of industrialisation and logistics zones. The CDC's advanced capabilities are successful enablers in economic zone development and management, real assets management, infrastructure planning and development for National, Provincial, Local Government Departments and State-owned Entities, technology integration while realising related socio-economic impact areas such as skills and SMME development. The foundational culture of the CDC's approach, backed by core values, is innovation and continuous improvement.

The CDC has been appointed by the Department of Education (DoE), KwaZulu-Natal Province to assist with rolling out Infrastructure projects for the KwaZulu-Natal School Building Programme.

INVITATION AND SCOPE OF SERVICES

The CDC is inviting capable and competent Contractors with an active CIDB grading of **7GB or higher**, potential emerging bidders of **6GB PE** will not be eligible to bid for the Construction of Thembinkosi Primary School, Osizweni, Amajuba District, KwaZulu-Natal.

The scope of work is as follows:

21 x standard classrooms, 4 x grade R classrooms, 2 x multipurpose laboratories and specialist rooms, 1 x media centre, 1 x computer room, 1 x team teaching room.

Administration block with Principal's Office, 1 x Deputy Principal's office, 1 x general office, 1 x printing room, 2 x sick rooms, 1 x entrance hall, 1 x counselling suite and 1 x staff room with kitchenette.

HOD offices garden stores, general storeroom and change room attached to standard classrooms, 1 x gate house, 1 x SNP kitchen, 10 x girls toilet seats, 7 x boys toilet seats, 6 x urinals, 2 x teacher's toilet seats, 6 x grade R toilet seats, 30 x parking bays, 1 x soccer field and paving from gate to admin block towards the new buildings.

General renovations to existing ablution block buildings, concrete walkways, parking and driveway, playground, planting of grass to certain areas, electrical installation, water and sewer management system.

CONDITIONS OF TENDER

- (a) Bidders shall be registered with the Construction Industry Development Board (CIDB) and should have a minimum active CIDB Contractor grading of **7 GB or higher** potential emerging contractors with **6GB PE CIDB grading** are not eligible to make submissions and will not be considered.
- (b) The following legislation shall apply:
 - (i) Public Finance Management Act (PFMA);
 - (ii) National Treasury Regulations;
 - (iii) Occupational Health and Safety Act and Regulations, Act (85 of 1993);
 - (iv) Compensation for Occupational Injuries and Disease Act (130 of 1993);
 - (v) B-BBEE Act Number 53 of 2003 (as amended by Act number 46 of 2013); and
 - (vi) Any other applicable legislation.
- (c) The **90/10** preference point system, as per the CDC interim Policy will apply. The formula for the allocation of points is provided under Section T1.2 Tender Data, Volume 1 of Tender Document. The following scores will be applied:
 - (i) Price - **90**,
 - (ii) B-BBEE Status - **10**.
- (d) Bidders and all its Consortium/Joint Venture (JV) members, if any, must confirm their company registration with Companies and Intellectual Property Commission (CIPC) (formerly CIPRO) as CDC will not award any bid to any business that appears on the CIPC List of de-registered businesses. The CDC may verify company registration with CIPC through BizPortal.
- (e) All Bidders must be Value Added Tax (VAT) Vendors and the Form of Offer must include VAT.
- (f) Bidders (all the members in the Bidding Team in the case of Consortia or Joint Ventures) must provide proof of registration on the National Treasury's Central Supplier Database (CSD) or provide a Treasury CSD registration number e.g. MAAAO
- (g) The CDC will only award the Bid to a Successful Bidder who is tax compliant. The tax compliant status of the Bidders (and all the members in the Bidding Team in the case of Consortia or Joint Ventures) will be verified through the CSD and South African Revenue Services (SARS) website.
- (h) As per amended construction codes, companies with less than 51% black shareholding (QSEs & Generics) are to submit a valid SANAS Accredited B-BBEE Verification Certificate (with the full applicable B-BBEE elements) QSE with at least 51% or 100% black shareholding and EMEs with an annual turnover of R 3 million are required to submit a B-BBEE verification certificate from a SANAS accredited verification agency as they have to comply with the 30% sub-minimum requirement on the QSE Skills Scorecard to avoid being discounted a level. EMEs with a turnover of less than R 3 million are exempt from complying with the subminimum requirement and may submit an affidavit or a certificate issued by CIPC, confirming their ownership and annual turnover.
- (i) In case of a Joint Venture (JV)/Consortium, a consolidated B-BBEE certificate would be required and it must be accompanied by individual B-BBEE Certificates/affidavits of their entities to confirm the type of enterprise.
- (j) Bidders must complete and sign the POPI Act form Q. In case of Joint Venture/Consortium, a separate form in respect of each party to the JV must be completed.
- (k) Bidders will be evaluated on functionality and are expected to meet the minimum of 60% threshold in order to be evaluated further. The evaluation criteria for measuring functionality and weight of each criteria are provided in the document.
- (l) CDC will not award more than two active projects to one bidder, unless one project has reached 80% completion stage and beyond. Capacity assessment may be conducted in an event that the recommended bidder is the only responsive service provider and has already been awarded two contracts.
- (m) Public servants are prohibited from conducting any form of business with organs of state, whether in their own capacity as individuals or through companies in which they are directors. Verification will be done and bidders will be disqualified should they be found to be in contravention with the regulations. A letter of confirmation must be provided with this bid document should a bidder have been granted permission by National Treasury to conduct business with an organ of state; and
- (n) The successful bidder will be required to comply with the Occupational Health and Safety Act and Regulations, Act (85 of 1993) and Compensation for Occupational injuries and disease Act, Act (130 of 1993) and, all relevant and applicable legislations. Upon appointment of the successful bidder, the service provider will be required to develop Occupational Health, Safety and Environmental Management Systems to comply with the SANS Norms and Standards. CDC SHEQ Unit will monitor compliance and implementation of Occupation Health and Safety, Environmental and Quality requirements for the duration of the contract.
- (o) Successful Bidder to comply with the requirement for Local Production and Content for designated items by the **dtic** and meet the minimum stipulated threshold(s) of:
 - Steel Value added products - 100% Stipulated minimum threshold
 - Electrical and telecom cables - 90% Stipulated minimum threshold
 - Plastic Pipes - 100% Stipulated minimum threshold
 - Cement - 100% Stipulated minimum threshold
- (p) A successful Bidder will be required to provide valid proof of registered Construction Health and Safety Officer/Manager (CHSO/M) with SACPCMP upon award. No candidate registration will be accepted. The CHSO/M must have proven record of minimum of five (5) years' experience or more.
- (q) No telephonic or any other form of communication with any other CDC member of staff, other Procurement representative, relating to this request for tender will be permitted. All enquiries regarding this tender must be in writing only and must be directed to e-mail: kzntenders@coega.co.za; no queries will be responded to after the **10 June 2022**.
