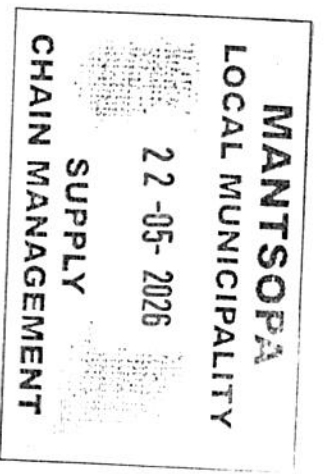

All the returnable documents will be listed in all the tender documents. The tender documents must be sealed in an envelope clearly marked with the relevant tender No. and description as stated above. Payments cannot be made at supply chain management offices but can be made at the municipal pay points: All Mantsopa offices. The tender documents will be available on 29 May 2026

Alternatively, direct or electronic deposits can be made to the MLM bank account: Std Bank account no: 371-180-538, branch code: 055534, reference no: the bid number, all bids' documents to be collected and submitted at: SCM offices, whereas tenders must be dropped at municipal tender boxes- 38 Joubert Street, Ladybrand.

1. Valid tax clearance certificate must be attached. (Pin Confirmation letter)
2. In case of the Joint Venture valid and the original valid tax clearance certificates of all parties must be attached.
3. Company Registration reflecting names and identity numbers of active shareholders must be attached.
4. In case of JV Certificate Copy of Company Registration Certificate reflecting names and identity number of active shareholders of all parties must be attached.
5. Copy of JV agreement (in case of JV) must be attached.
6. If any municipal rates, taxes, or service charges owed by the bidder or its directors to the municipality are in arrears for over and older than three months, the supplier will be disqualified.
7. In case of a JV Municipal Rates and Taxes Account all parties must attached Municipal Rates and Taxes Account. Failure to submit will be disqualification. Municipal Rates and Taxes must not be in areas and older than 90 days.
8. In case of JV a consolidated CSD must be attached, failure to attach will result in disqualification.
9. No bid will be considered from the persons in the Service/Employment of the State/Government/State Owned Entities.
10. Completion of MBD 6.1 form and must be substantiated by CSD and will be verified. Bidders who fail to complete will forfeit preferential points.
11. Completion of MBD 4 is compulsory, failure to do so will result in disqualification.
12. The service provider must be registered on the Central Supplier Database of the national treasury. Failure to register on CSD will lead to disqualification.
13. Bids must be valid for a minimum period of 90 days.
14. All pages of the Bid Document must be signed and initialled where applicable. Failure to do so will be a disqualification.

Please note: In order to protect its interest Mantsopa local municipality reserves the right not to accept the lowest or any bid. Any late bid will not be accepted. It should be noted that it is the responsibility of the bidder to ensure that his/her bid is deposited in the tender box on or before the stipulated time.
