

London -Manchester City's latest recruit, Antoine Semenyo, won praise from fellow teammates and support staff after the 26-year-old scored on his debut in Saturday's 10-1 FA Cup victory over Exeter City, matching the team's biggest win in the competition.

Ghanaian winger Semenyo, who has 10 league goals and three assists this season, joined City earlier in the week, after competition from other Premier League

rivals. "Antoine is settling well," assistant manager Pep Lijnders, who took charge with Pep Guardiola serving a one-game touchline ban, told reporters.

"He is a humble guy and we have followed him for a long time, but he brings something to the frontline – what we really want and what we need."

"He can attack quickly, he wants to chase and he is a guy who doesn't stop. I think you saw today that he can adapt quickly to our style."

Semenyo slipped a weighted pass to defender Rico Lewis for City's fifth in the 49th minute and, five minutes later, got himself on the scoresheet with a shot from inside the penalty area. "Everybody wanted him [Semenyo]; there's a reason for that and he's shown that today," Lewis told the club's official website. "It feels like a seamless transition into the team."
