Request from Accounting Firms/ Consulting firms for Tax Advisory Services on Value Added Tax. SARS has been conducting a VAT audit since 2023 for financial years 2019. Numerous information requests and meetings have been held to provide SARS with the necessary materials and explanations however, it appears that the scope of the audit/investigation is undefined as there has been no conclusion on any of the requests or matters raised. The audit has been dragging for too long beyond expected timelines and assistance is therefore required from Tax experts to assist UUW in dealing with this audit and queries being raised in line with VAT act and TAA act. No assessment has been raised by SARS as yet.

## 2. What we are buying and why

- 2.1. Technical expertise of tax advisory services to assist with consultation in relation to Value Added Tax (VAT) as well as the Tax Administration Act (TAA), particularly to respond and conclude to SARS audit verification that is on-going.

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
