

SPECIFICATION FOR THE PROVISION OF MEDICAL TEST TO OPERATIONS PERSONNEL FOR POLOKWANE INTERNATIONAL AIRPORT FOR A PERIOD OF 3 YEARS.

1. INTRODUCTION

Gateway Airport Authority Limited (GAAL) seeks to appoint suitably qualified, reputable, and experienced Occupational Health Practitioner to conduct medical test for operations personnel (AVSEC Security Officials, Rescue and Fire Fighting and other personnel working with AVOP/PARTAC) based at Polokwane International Airport for a period of 3 years.

South African Civil Aviation Authority (SACAA) and Fire Brigade Act, requires that all applicants for or the holder of Screener Certification and AVOP/PARTAC and rescue and firefighting personnel respectively must obtain a medical certificate issued by a licensed Occupational Health Practitioner.

2. SCOPE OF WORK

The following is the scope of work which involves testing which must be conducted:

1.	Eyesight Test With or without spectacles or contact lenses, have distant vision correctable to 20/40 or better in his/her eye and 20/100 or better in the worst eye. Good vision is essential in firefighting for dealing with incidents with poor visibility or night-time work. There can be a disqualification for those with monochromatic vision, far visual acuity that is less than 20/40 binocular vision or a peripheral vision less than 110 degrees.	37
2.	Color Perception Test Does not suffer color blindness	34
3.	Hearing Test With or without audio aid be able to hear a sound from 26 decibel's	37

	Fire & Rescue personnel need to hear instructions and indications of dangers on the scene in loud, confusing situations. Therefore, the hearing test is essential. The test is simple with a series of responses to stimuli in a soundproof room. Those that underperform at the different frequencies may struggle on-site. There are also disqualifications for conditions that could prove dangerous, such as uncorrected tinnitus, Meniere's syndrome or labyrinthitis.	
4.	Chemical Dependency Test Be free from dependence on alcohol or illegal substances, as determined using the 5-panel drug test. Applicants taking a prescribed drug should be considered individually to ensure that their ability to undertake their duties is not adversely affected.	34
5	Vital health signs to be tested / assessed / evaluated. Blood pressure, Heart rate and Oxygen level (pulse ox) are an indication of general fitness level. Poor results here could indicate poor physical fitness but also underlying health issues that may need medical intervention. Body mass index (BMI) and will use skinfold tests for a ratio of fat to muscle.	22
6	Blood test Blood testing is vital in highlighting possible health risks. Consideration of look at white and red blood cell counts as well as glucose levels. These can indicate diseases that are perhaps undetected or poorly managed. It is also a good way to test alcohol levels for substance abuse.	22
7	Urinalysis Urinalysis is primarily for drug tests. The compounds and consistency of the fluid can indicate major diseases and small infections.	22

	A chest x-ray gives an up-close look at the health of lungs and heart. This means checking the lungs for damage or obstruction, spotting potential problems with the heart, and looking at the major blood vessels. This is the perfect chance to locate something small that could end up being a ticking time-bomb.	
9	Pulmonary tests Breath tests with spirometers determine a candidate's lung function through inhalation and exhalation. A poor rate could be dangerous in a smoke-filled room even with a mask on.	22
10	Treadmill test (stress test) The treadmill is the perfect way for gauging the cardio and respiratory function of the applicants. This test is about endurance and assist to assess if the candidate can maintain the right heart rate and performance at specified age categories.	22
11	Functional movement screening Functional movement essentially means the way the body can move with the range of motion of the limbs, flexibility of the joints and perhaps also the strength of the muscles. Flexibility is essential in the hamstring muscles, lower back, and shoulders. It helps firefighters move around dangerous areas and handle equipment with less risk of injury.	22

All documents must be completed and signed in black ink by the duly authorised representative of the prospective bidder(s). **Correction fluid is not allowed and any cancellation on the bid document must be initialled by the authorized signatory.** During this phase, Bidders' responses will be evaluated based on compliance with the listed administration and mandatory bid requirements. The bidder(s) quotation will be disqualified for non-submission of any of the documents.

3.2 Gate 2: Functionality Evaluation Criteria

All suppliers are required to respond to the functionality evaluation criteria.

Only suppliers that have met the administrative requirements in (Gate 0) will be evaluated in Gate 1 for functionality as per below table:

The maximum points that can be scored on functionality equals to 100. Suppliers scoring less than 60 points will be disqualified.

Suppliers that fail to meet the minimum threshold for functionality will be disqualified. Thereafter, **only the qualifying quotations will be evaluated in terms of the 80/20.**

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point

system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
