## **SCOPE OF WORK/SPECIFICATIONS/ REQUIREMENTS:**

### **BACKGROUND & or SCOPE OF WORK**

#### **1. BACKGROUND AND OBJECTIVES**

This Procurement relates to the Supply, Delivery, and Installation of New Mobile Ablution Facility for Msinsi Hazelmere Dam.

#### **2. SCOPE OF WORK /TERMS OF REFERENCE**

- Contractor to supply, deliver and install two new mobile ablutions facility fully fitted.
- The size of the mobile ablutions facility is 6m long and 3, 05m wide with 2m height of mobile container.
- In each mobile ablution facility must have two separate sections with each door for male and female section.
- Each gender section should have two toilets.
- Each gender section should have two wash hands sink with double quality taps or equivalent to cobra taps fitted.
- Each gender section should have two shower fitted.
- Each male toilet should have single urinal fitted.
- Each gender section should have two light switch and two double tube light fitted.
- Each gender section should have one geyser isolator and one 200l geyser fitted.
- Each gender section should have fitted plumbing to enable connection of water and to a soak pit.
- Each gender section should have external surface mounted DB and earth leakage fitted.
- Each gender section should have two (600x900mm) and four (500x500mm) sliding windows burglar bars included, two exterior doors and four interior doors fitted.
- Floor must be 2mm heavy duty industrial vinyl and doorsteps are required in each door wind the steps signs.
- Each mobile ablutions facility should have six tripod stands (150mm).
- All installation, provision of concrete pads/slaps for tripod stands work to be done by the contractor where the mobile ablutions facility will sitting to ensure that are leveled or even.

- Provision of certificate of compliance for electrical and plumbing works/fittings.

#### Chassis

- Chassis constructed to run the full length and width of the building, two pre-galvanised 200x75x20x3mm cold formed lip channel longitudinal main members run centrally the length of the building at 1640mm centres. Pre-galvanised 75x50x20x2.5mm cold formed lip channel cross members are structurally welded at 600mm centres spanning the width of the building.

#### Floor construction

- 18mm exterior hardwood (WBP) ply floorboard fixed onto the cross members with 12x45mm counter sunk galvanised wingtex screws.
- The floorboard constructed with 7 ply layers bonded under heat and hydraulic pressure using exterior grade adhesive as stipulated under SANS 929:2008.
- 2mm heavy duty industrial vinyl bonded to the floorboard using WD91 floor adhesive and all joints are plastic welded to form a watertight seal between vinyl strips.

#### External and Internal Walls

- Panels manufactured by injecting a two-part polyurethane substrate between two cladding layers in a heated moulding system.
- Claddings with frost white 0.5mm ISQ230 (Z100) pre-painted hot-dip galvanised steel Chromadek.
- Where framing is utilised, all timber is treated in accordance with SANS 1288 using Tanalath CCA oxide (3302) having a composition as follows: Copper (CU) 33.85%, chrome (CR) 41.45% and arsenic (As) 24.70%.
- The timber treated using a vacuum pressure system of impregnation to a minimum dry salt retention of 6kg/m<sup>3</sup>.
- Thermal properties are 25-30% superior to polystyrene and at least 70%
- Long term thermal resistance is achieved between -30°C and 90°C, temperatures of up to 250°C can be withstood for a short period without damage.
- Closed cell foam is packed at density 38-40kg/m<sup>3</sup> and has fire retardant properties compliant with SANS 10177-2.

#### Windows

- Manufactured from aluminium extrusions and naturally anodised as standard.
- Windows manufactured as sliding and fitted with 4mm clear safety glass with obscure being fitted in ablution areas.
- All windows manufactured in accordance with SANS 10400 Part N. Standard window size widths 600mm and heights of 900mm.

#### Doors

- Manufactured as a composite door, typically frost white 0.5mm ISQ230 (Z100) pre-painted hot-dip galvanised steel Chromodek smooth sheets are fixed either side of a timber frame and injected with polyurethane insulation.
- Timber is all SA pine treated in accordance with SANS 1228:1994.
- Door leave must be fitted with three aluminium naturally anodised sinkless door hinges which is fixed into an aluminium naturally anodised door frame.
- Union 3 lever locksets with zinc back plates fitted as standard.

#### Roofing

- Roofing panels, timber used must be treated in accordance SANS 1288, lattice beams must be manufactured from 40x40x3mm angle iron.
- Ceiling finish must be white wallpaper and positioned on top of walls and fixed into place using 12x100mm screws on all panels and partitions.
- 38x38mm Battens must run across trusses at 300-500mm centres depending on unit width and type with 0.58mm gembok sand corrugated ISQ300 (Z200) roof sheets fixed on top.
- Rubber polyclosures must be under roof sheets and ridge capping to ensure weather proofing.

#### Electricity

- All units must be wired for connecting to a 220v single phase supply as standard, with the exception of multi span type units.
- All electrics must be in accordance with SANS 10142-1 and are fitted with earth leakage protection within the distribution board
- Electrics are run within the ceiling void and cored into the panels, PVC boxes are inserted into panels and front plates are screwed over.

## Plumbing

- All plumbing works must be fitted in line with the building regulation codes and all fittings are SABS approved.

## Finishing

- All corners, edges, ridge capping's and voids are neatly finished off with purpose made trims and flashings made from 0.58mm Chromadek sheeting.

## 2. The offered rates must be inclusive of material and labour.

Prospective tenderers must certify that they are in possession of a policy covering their liability to any workman on site in terms of the Compensation for Occupational Injuries and Diseases Act.

They must further certify that they are aware of the onus placed on them in terms of the Occupational Health and Safety Act 85 of 1993 and amendments and that their employees have been versed in the same.

The successful tenderer must abide by Msinsi Holdings Rules for Contractors on Site and sign the relevant documents as acceptance.

A Works Programme must accompany the quotation. The Reserve Manager must be informed when work is to commence on site. Any deviation from the specification and the Bill of Quantities must be authorised by the Reserve Manager.

## 3. Need to include Msinsi Holdings requirements after award

- A site appointment is to be made with the respective SHEQ Coordinator via the Project, prior to the contractor carrying out any work on the respective site.
- Submission, review and approval of safety file needs to be conducted prior to undertaking any work.
- On induction, the Contractor must produce copies of identity documents of all staff that will be working on site as well as a valid letter of good standing.

- The contractor will be required to complete a Work Permit. The Work Permit shall be completed for each day of work.
- Access control arrangements shall be made prior to or at the time of signing all the documents. All keys shall be signed for and returned daily. NB: Contact details (e.g. cell phone number must be given to site management for emergency purposes).
- Failure to ensure that all site specific procedures relating to Safety, Security, Health and Environment are not followed shall mean that the contractor is deemed negligent.
