Dube TradePort Corporation seeks to appoint suitably qualified professional service providers to undertake water quality monitoring, project management and prepare reports on surface and groundwater water sampling over a 3-year period. The service provider must have South African Council for Natural Scientific Professions (SACNASP) accredited resources, and the service provider must use a SANAS accredited company to analyze the water samples.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.
