### **INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver the Conservation Mandate by Excelling in the Management of a National Park System

### **BUSINESS UNIT RESPONSIBLE FOR THE BID**

This BID will be led by the Agulhas National Park (ANP) Management team. Agulhas National Park (ANP) is managed by South African National Parks. The Park is located around the town of Agulhas in the Western Cape Province in the Republic of South Africa.

## CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for the appointment of a service provider for the Supply and Delivery of Hardware Materials at Agulhas National Park for a period of 5 years will be based on an as and when required basis.

## CONTRACT PERIOD

The contract will be for a period of **60 months (5 years)**.

## SPECIFICATIONS/SCOPE OF WORK

SANParks seeks to appoint a reputable service provider that has the capability of Supply and Delivery of Hardware Materials at Agulhas National Park. The quality of the supplied products shall be in accordance with SANS and applicable standards. The required services will be contracted for a period of sixty (60) months.

### 1. CONDITIONS

- All goods or services purchased will be subjected to South African National Parks Conditions of Contract;
- Penalty Clause (supply and delivery of hardware materials): Standing time penalties to be effective after twenty-four hours (24) of standing time.
- All staff will be subject to integrity testing as and when required

## DELIVERABLES

- SANParks reserve the right to Collect (pick up) the materials from the supplier's premises or any other agreed-upon location, should the materials be ready and delivery is not required.
- Quantities required per delivery shall be confirmed by a purchase order and delivery should be within 7 days from the date of issue of the purchase order.
- All items must be of good quality and must comply with the SABS standards. All electrical and other items must be SABS approved.

## RESPONSIBILITIES OF SANPARKS

- To provide the tendering company with information that will assist in submitting the tender.
- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behavior will be prevented for future occurrences.

- The service provider may not assign or subcontract any part of the order without the written consent of the Agulhas National Park.

This may include the involvement of other service providers and the service provider will not have any claim because of the actions taken by SANParks.

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favorable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
