**1. IMPORTANT NOTICE**

- 1.1. The bidder must read this bid document diligently and where possible take advice or refer to the relevant legislation and regulation applicable to procurement.
- 1.2. The bid document must be completed in black ink and in full, correctly and truthfully. Provided that it's not relevant to the bidder, it must be marked "**NIA**".
- 1.3. Bid documents must be sealed when submitted. The submission must be delivered at the correct address as it reads from this bid document on or before the closing date and before the closing time. The correct time to be used will be Telkom time. No submission shall be accepted other than in the manner described in this paragraph.
- 1.4. Information requested must be provided. Such information must be genuine. Should information be a copy of the original, such copy must be certified and commissioned as the true copy of the original in terms of the relevant laws.
- 1.5. Documents requested [including those under "returnable documents" under specifications / terms of reference] must be attached at the end of that particular annexure requesting such information. 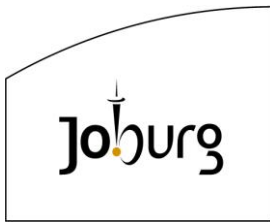

- 1.8. **Error/s made must be scratched and signed next to the error by the same person who signs the bid document. Therefore, no tipex is allowed. **2 CONDITIONS OF BID**

- 2.1. No bid will be accepted from persons in the service of the state as defined in the Municipal Finance Management Act and Regulations.
- 2.2. The bid terms and conditions remain binding to the bidder throughout the contracting period.
- 2.3. A consideration of this bid is subject to governing legislation, including those relating to B-BBEE, the City's development goals, Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations as amended.
- 2.4. That the tender may not necessarily be awarded to the bidder scoring the highest points.
- 2.5. The bidder is prohibited from participating in any form of price manipulation or bid rigging including those in MBD 9. If found, the bidder will be disqualified, or award be terminated.
- 2.6. Negotiations will only be conducted with selected bidder/s where necessary.
- 2.7. An award may be made to more than one bidder.
- 2.8. If considered necessary, the municipality reserves the right to visit the bidder's place of business and/or its customers.
- 2.9. The specifications are the copyright of the municipality.
- 2.10. The municipality reserves the right to cancel the requests for bids at any time or stage before the award or not to accept any bid.
- 2.11. Should it be found that the bidder has not been truthful and/or dishonest, then municipality shall cancel the award and negotiate with the next acceptable bidder.
- 2.12. All bids will be treated as confidential to the extent that the Municipality is required by law to publish or make information in the bid available to a third party.
- 2.13. Any dispute arising out of or relating to the bid must first be referred to the Accounting Officer for resolution.

**2.14. Remedies**

- (1) If an organ of state is of the view that a tenderer submitted false information regarding a specific goal, the City of Johannesburg will —
  - (a) inform the tenderer accordingly; and
  - (b) give the tenderer an opportunity to make representations within 14 days as to why the tender may not be disqualified or, if the tender has already been awarded to the tenderer, the contract should not be terminated in whole or in part.
- (2) After considering the representations referred to in subparagraph (2.14) (b), the City of Johannesburg may, if it concludes that such information is false—
  - (a) disqualify the tenderer or terminate the contract in whole or in part; and
  - (b) if applicable, claim damages from the tenderer.

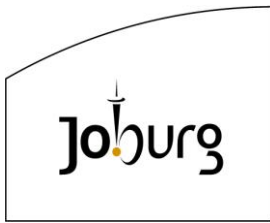
2.15. The tender may be divisible and be awarded to more than one bidder.

2.16. The City reserves the right to award the bid in full, partially or not at all.

**3. TERMS AND CONDITIONS FOR BIDDING [Part B – Tax Compliance Requirements]**

- 3.1. Bidders must ensure compliance with their tax obligations.
- 3.2. Bidders are required to submit their unique personal identification number (PIN) issued by the South Africa Revenue Services (SARS) to enable the organ of state to view the taxpayer's profile and tax status.

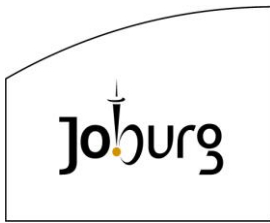

**4. TAX MATTERS**

**It is a condition of the bid that the taxes of the successful bidder must be in order as at the date of award, or that satisfactory arrangements have been made with SARS to meet the bidder's tax obligations as at the date of award. 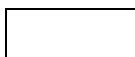

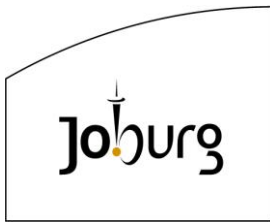

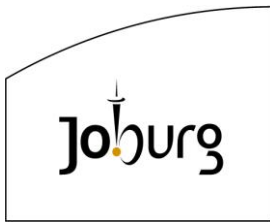
**5. GENERAL TERMS AND CONDITIONS OF THE CONTRACT**

- a) In this document words in the singular also refer to the plural and *vice versa* and words in the masculine also mean in the feminine and neuter.
- b) The General Conditions of Contract (GCC) will form part of all bid documents and may not be amended.
- c) Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the GCC. Whenever there is a conflict, the provisions in the SCC shall prevail.
- d) Wherever the following words appear, they will have interchangeable meaning: "purchaser" refers to the "municipality" and "supplier" refers to the "bidder".

Definitions

- 1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

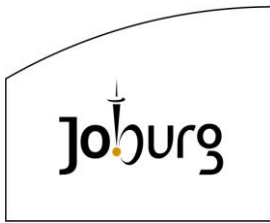

- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery *ex stock*" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "*Force majeure*" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.

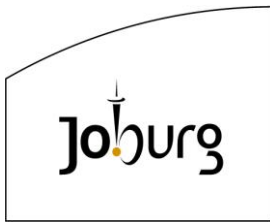

- 1.21 “Purchaser” means the organization purchasing the goods.
- 1.22 “Republic” means the Republic of South Africa.
- 1.23 “SCC” means the Special Conditions of Contract.
- 1.24 “Services” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

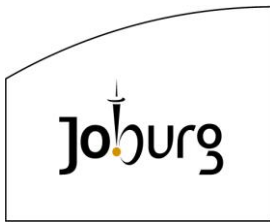

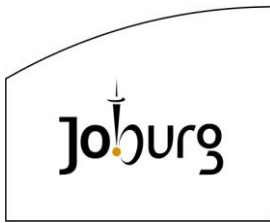

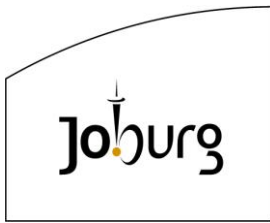

- 7.3. The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

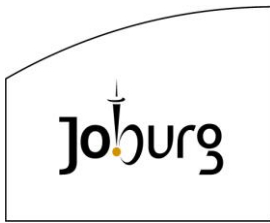

- 8.5. Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7. Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. 9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. 15. Warranty

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract.
- 15.2. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

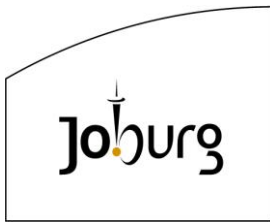

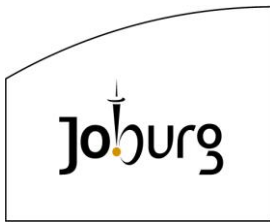
20. Subcontracts

20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s).

As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.4. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.5. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.6. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

**22. Penalties**

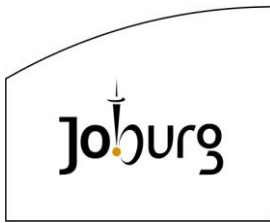
22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

**23. Termination for default**

23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the supplier fails to perform any other obligation(s) under the contract; if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

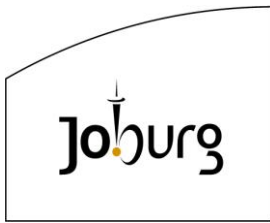

- 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 (ten) years.
- 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than 14 (fourteen) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated 14 (fourteen) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.
- 23.5. Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6. If a restriction is imposed, the purchaser must, within 5 (five) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
  - (ii) the date of commencement of the restriction
  - (iii) the period of restriction; and
  - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than 5 (five) years and not more than 10 (ten) years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

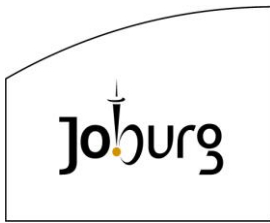
24.1. When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase.

24.2. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure

25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if

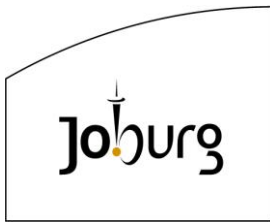
26. Termination for insolvency

- 26.1. The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

If, after 30 (thirty) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

28. Governing language

28.1. The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

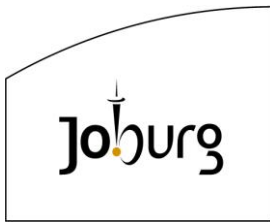

# **TERMS OF REFERENCE: ACCOUNTING SOFTWARE TOOL FOR THE PREPARATION OF (SEPERATE AND CONSOLIDATED) FINANCIAL STATEMENTS AND MANAGEMENT REPORTS**

## **1. PURPOSE**

The purpose of this terms of reference is to invite suitably qualified service providers to the City of Johannesburg (CoJ) to supply, install, deploy, support and maintain a software tool that automates the entire financial reporting process that produces quality Generally Recognised Accounting Practices (GRAP) and Municipal Standard Chart of Accounts (mSCOA) compliant financial statements and management reports for the City and its entities for a period of three years.

## **2. BACKGROUND**

The City of Johannesburg Metropolitan Municipality is a Category A municipality as defined in the Constitution of the Republic of South Africa and the Local Government: Municipal Structures Act. The CoJ provides municipal services to the community of Johannesburg through a number of municipal entities and a number of departments and business units within its core administration. The City's administration is centralized within sixteen (16) core departments which together are reported as one controlling entity called Core as well as thirteen (13) Municipal Entities (MEs).

The City of Johannesburg Metropolitan Municipality (Core) and its municipal entities are required to prepare financial reports on monthly, annually and as and when required. These reports include:

- 2.1 Financial statements - In terms of section 122 of the Municipal Financial Management Act (MFMA), The City and its entities must prepare separate Annual Financial Statements (AFS). In addition, the City must prepare consolidated AFS. Both separate AFS and consolidated AFS must be prepared in accordance with standards of GRAP.
- 2.2 Monthly section 71 budget reports - In terms of section 71 of the MFMA, the municipality must submit budget reports on the state of the municipality's budget on a monthly basis to the National Treasury. The budget reports should be in the format prescribed by the National Treasury.

- 2.3 Monthly management reporting - These are prepared in accordance with management's operational requirements to be able to monitor the City's finances and take necessary decisions based on these reports. The format can be changed to cater for management's immediate needs.
- 2.4 In addition to the above requirements the City must at all times consolidate financial information of all entities to report as an economic entity.
- 2.5 The information above is compiled from trial balances which are derived from various financial systems used by Core and entities

It is against this background that the City of Johannesburg (COJ) is approaching service providers to submit proposals to provide the software tool for the preparation of financial statements and management reports, as detailed above.

### **3. CURRENT ENVIRONMENT**

#### **3.1 Accounting system**

Core uses the SAP ERP system as the main accounting system and three (3) of the twelve entities also use SAP ERP system,

Other entities use the following accounting systems:

- 3.1.1 Sage Intacct
- 3.1.2 Sage Pastel
- 3.1.3 Sage Evolution
- 3.1.4 J.D.E
- 3.1.5 Great Plains
- 3.1.6 Microsoft GP
- 3.1.7 Nicor system

#### **3.2 Number of users**

- 3.2.1 Each entity has a team with an average of 8 personnel responsible for the preparation of the financial reports indicated above.
- 3.2.2 Core Accounting has an estimated number of 10 people responsible for the preparation of financial reports indicated above.
- 3.2.3 Group Accounting has an estimated number of 16 people responsible for the preparation of consolidated financial reports and budget reports indicated above.

3.2.4 All entities operate on their own premises in separate buildings.

### 3.3 Size and number of accounts

Each entity has an average of 4000 accounts on their trial balance while Core has an estimated number of 50 000 accounts on their trial balance.

## 4. PROJECT SCOPE AND DELIVERABLES

The scope of work of this bid is to appoint a service provider that can provide the City and its MEs with software licenses, training, support and maintenance of the software.

### 4.1 Software tool

The software tool to be provided by the service provider must enable the City to:

#### 4.1.1 Compatibility

4.1.1.1 The software tool must be able to seamlessly integrate and import the trial balance from the various accounting systems used by the City and its entities mentioned above in 3.1.

4.1.1.2 The software tool should integrate and automate additional schedules and reports within the working file convertible to Microsoft and PDF format.

4.1.1.3 The software tool must be compatible with Microsoft applications.

4.1.1.4 The software tool must be compatible to all the accounting software systems listed mentioned above in 3.1 and the successful service provider must be able to ensure seamless integration.

4.1.1.5 The software tool must be aligned to the City's GICT policies and standards.

4.1.1.6 Integration should support the following:

- i. Automated scheduled imports
- ii. Manual on-demand imports
- iii. Error handling and validation during import process
- iv. Audit trail of all data imports

#### 4.1.2 Automated reports

4.1.2.1 The software tool must have GRAP compliant templates so that the end user will be able to produce financial statements that are in compliance with the Generally Recognized Accounting standards.

4.1.2.2 The software tool must be able to produce automated monthly section 71 reports that are compliant to National Treasury requirements using data from the trial balance.

4.1.2.3 The software tool must ensure that templates will fully comply with mSCOA and

the accompanying National Treasury monthly reporting requirements.

4.1.2.4 The software tool must allow for breakdown of reports per department, per entity, per cluster and per month.

4.1.2.5 The software tool should allow users the ability to customize financial statements/reports if required.

The software tool should allow users the ability to customise financial statements or reports if required, while maintaining compliance guardrails that:

- i. Prevent removal of mandatory GRAP and Treasury disclosures
- ii. Flag potential compliance issues when customisations are made
- iii. Maintain audit trail of all customizations
- iv. Allow reverting to compliant templates if needed

4.1.2.6 The software tool must be able to extract budget information from the underlying accounting system, import into excel, forecast, and populate this information on the automated reports.

4.1.2.7 The software tool must be able to extract financial information from underlying accounting systems of all entities' trial balances and produce automated consolidated financial statements that are GRAP compliant.

4.1.2.8 This tool must ensure continuous compliance with all GRAP and MFMA disclosures, particularly taking into account the rapidly changing standards of GRAP and National Treasury requirements.

4.1.2.9 The software tool must be able to facilitate adding a new disclosure note reference or modifying and customise an existing disclosure note to meet specific disclosure requirements. When a new disclosure note is inserted, all referencing and numbering on the entire report (financial statements/section 71) must be automatically updated.

4.1.2.10 The drafting and completion of supporting documents must be automated through a user-friendly interface, thus enabling the City and MEs to prepare comprehensive working paper files.

#### 4.1.3 Other Functionality

4.1.3.1 The software tool must enable the users to process journals including a function for a mass upload of unlimited journal, fully referenced including date, journal numbers and type. In addition, the software tool must be able to separate between normal journals, elimination journals and prior year journals. The software tool must enable the users to easily access a

breakdown/drilldown of any line item of the financial statements for trial balance detail.

4.1.3.2 The software tool must be able to allow easy access to entities' files from different premises for the purposes of uploading, downloading and back-up on a cloud.

4.1.3.3 The software tool must be completely network-ready and run on the City's standard operating system. The service provider must set up security to define the rights of each staff member.

4.1.3.4 Export of the financial statements to PDF and Microsoft Word, and it must be able to export journals and trial balances from this software to Excel.

#### **4.2 Maintenance and Support**

4.2.1 The service provider must be able to provide support via ad hoc services as and when required by the City.

4.2.2 Service provider must be able to provide a help-desk support accessible through email/telephone or via remote access to respond to queries with regards to the software.

5.1.10 Municipal rates and taxes for the company and directors not older than three (3) months and not in arrears for more than 90 days or affidavit or lease agreement.

5.1.11 Certified copies of qualifications.

5.1.12 Project proposal outline the methodology and approach requirements and addressing the terms of reference as set out on the tender.

5.1.13 Screenshot/wireframes of Software tool demonstrating GRAP templates and mSCOA compliant trail balance.

5.1.14 In case the bidder is a reseller or a partner, they must provide evidence of an agreement from the Original Equipment Manufacturer (OEM) on a signed company letter head or bidder must confirm through a signed confirmation letter that they are the OEM.



## **5.2 Disqualifying criteria**

- 5.2.1 Failure to complete a bid form.
- 5.2.1 Failure to complete the City of Johannesburg pricing schedule in full.
- 5.2.2 Failure to attach a letter on a company letterhead confirming errors or alterations on the pricing schedule.
- 5.2.3 Failure to attend the compulsory briefing session.

## **5.3 Conditions of award**

Notwithstanding the suppliers' proposal being recommended for award, an award shall not be made to a supplier whose:

- 5.3.4 Name of the bidder or that of its directors appear on the National Treasury's database of Restricted Suppliers.
- 5.3.5 In case the bidder is a reseller or a partner, they must provide evidence of an agreement from the Original Equipment Manufacturer (OEM) on a signed company letter head or bidder must confirm through a signed confirmation letter that they are the OEM.

## **6 DURATION OF THE CONTRACT**

The contract with the successful service provider will be for a period of three years. At the expiry date, the contract will be automatically terminated.

## **7 EVALUATION CRITERIA**

- 7.1 The assessment of functionality shall be done in terms of the evaluation criteria and the minimum threshold stipulated. Bidders will be evaluated and scored on the minimum threshold stipulated. Bidders will be evaluated and scored on the functionality elements.

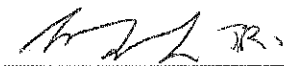
