 - . Special Conditions of Contract (SCC) relevant to a specific Bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract.
- Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 **"Closing time"** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 **"Contract"** means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 **"Contract price"** means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 **"Corrupt practice"** means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 **"Countervailing duties"** are imposed in cases where an enterprise abroad is subsidised by its government and encouraged to market its products internationally.
- 1.6 **"Country of origin"** means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognised new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 **"Day"** means calendar day.
- 1.8 **"Delivery"** means delivery in compliance of the conditions of the contract or order.
- 1.9 **"Delivery ex stock"** means immediate delivery directly from stock actually on hand.
- 1.10 **"Delivery into consignees store or to his site"** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 **"Dumping"** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

3. INTRODUCTION

- 3.1. The Department invites request for bids for renting of Tuck-shop services in the Limpopo Department of Health.
- 3.2. Given the nature of this service, the appointed service provider is expected to rent structural facilities in the institution premises for conducting the services, it is therefore necessary to have their own equipment.
- 3.3. It is expected that appointed service provider shall operate the facilities on all weekdays at the hospitals including the public holidays. The operating times shall be negotiated and arranged between institutions and the service provider and included in the SLA.
- 3.4. The service provider shall be responsible for the cleanliness of the Tuck-shop and its environment, ablution facilities used, and hygiene of commodities sold.
- 3.5. The bid will be an accreditation of service providers and services will be activated as and when the need arises to all institutions.

4. SCOPE OF WORK

- 4.1. The appointed service provider must provide tuck-shop services in all the hospitals and institutions: -
- 4.1.1. The tuck-shop will sell items like **toiletries**, basic meals, snacks, non-alcoholic drinks, excluding intoxicating substances and tobacco products on a daily basis.
- 4.1.2. Duration of the Service: The intended term of the contract will be a period of thirty six (36) months from date of awarding the contract.
- 4.2. Normal Service Time: – Hospitals (including Public Holidays) Mon to Sun – 07h00 to 19h00. Week days – Administrative Offices (excluding weekends and Public Holidays) Mon to Fri – 07h00 to 16h30. The appointed service provider must be prepared to cater for the following:

5. REQUIREMENTS / OBLIGATIONS OF THE SERVICE PROVIDER

- 5.1. Conduct business in courteous and professional manner.
- 5.2. Provide healthy and nutritious meals from time to time.
- 5.3. Comply with the Department of Health security personnel and emergency policies, procedures and regulations.
- 5.4. Ensure that all work performed, and all vehicles, plant and equipment brought onto or used onsite will be in compliance with the Occupational Health and Safety Act 85 of 1993 and any Regulations promulgated in terms of this Act the standards instruction of the Department of health.
- 5.5. Provide all personnel working under this contract with adequate and appropriate Personnel Protective Equipment (PPE) and clothing and to ensure these items are always worn and clean.
- 5.6. Provide the services of pest control and general cleanliness to the tuck-shop and surrounding areas at his or her own cost and continuous basis.
- 5.7. Provide compulsory catering equipment such as hot food bar, microwaves, refrigerators and stoves which are in good working conditions.
- 5.8. Willing to sign a detailed Service Level Agreement with the Department before occupation of the tuck-shop.
- 5.9. **Advance payment for all applicable fees must be paid in advance on or before the 03rd of each month.**

6. RESPONSIBILITY OF THE DEPARTMENT

- 6.1. Conduct business in a courteous and professional manner with the service provider.
- 6.2. Provide appropriate information as and when required and only in situations where it is required by the Service Provider to fulfil their duties.
- 6.3. Not accept responsibility for any damages suffered by the Service Provider or their personnel or their customers for the duration of the contract.
- 6.4. Not accept any responsibility of accounts/expenses incurred by the Service Provider that was not agreed upon by the contracting parties.
- 6.5. Shall provide an operation area with the storage facilities for equipment and material.
- 6.6. Shall provide the following (as per prescribed tariffs):
 - 6.6.1. Electricity, water and sanitation.
 - 6.6.2. Landline points and extension number.

6.6.3. Parking area for loading and offloading

7. RESPONSIBILITY OF THE SERVICE PROVIDER

- 7.1. Conduct business in a courteous and professional manner with the department.
- 7.2. Provide appropriate information as and when required by the department.
- 7.3. Responsible of all their accounts and expenses.
- 7.4. Shall maintain all the provided areas / facilities and equipment.
- 7.5. To provide alternative resources in case of water and electricity shedding.

8. BUILDING ALTERATION / INSTALLATION OF FIXED EQUIPMENT

- 9.1. In a case where the two parties are in dispute and the service provider opts to end the service such must be done in writing 30 days before the service provider vacate the premises.
- 9.2. The Department will refund the balance for the remaining months of the contract provided there is no other solution to the matter in dispute. A termination/ penalty fee of **50%** of the remaining months fee will be charged in case the service provider on its own accord ends or abandons the service with or without notifying the Department.

11. SCHEDULE – TUCKSHOP SERVICES

- 11.1. The above is just an example and interested service providers are at liberty to draft their balanced menus, mindful at all times that Health Inspectors and other related officials will from time to time inspect the quality of food prepared and/ or served.
- 11.2. The interested service providers should further take note that customers' menu need to change from time to time and it will be in their interest to rotate their menus to attract the interest of their customers.
- 11.3. The appointed service provider will be expected to operate a Tuckshop facility for tea, drinks, light refreshments and meal. All edible items may be sold except, hardware such as knives, scissors, utensils, cookware etc. All types of drinks may be sold except liquor and any intoxicating substances.

12. Note well:

- 12.1. Contractual problems arising from exorbitant price per month quoted by bidders and also street vendors selling the same items as bidders within the vicinity of the institution will not be entered into.
- 12.2. Bidders must therefore be conscious when quoting for facility rental per month, taking into consideration overheads and profit.
- 12.3. The bidder must conduct own research to establish degree of possible business, and then make a monthly rental fee offer to the institution of choice.
