5. Scope for Future Ad Hoc Services

The prospective service provider may be requested to render the security services at any municipal office or facilities where the service may be required. Such *ad hoc* service may be required at any place within the jurisdiction of the Umzimvubu local municipality. When special services are required, the successful and contracted security provider shall be expected to use the same rates as per the signed contract and service level agreement (SLA). *Ad hoc* services shall be handled as stated in paragraph 18 below.

The purpose of this special service is to cover all municipal special events where security services is required.

6. Other municipal facilities.

The prospective service provider may be requested to render the security services at any municipal facility not mentioned above. It is expected that the prospective provider must have the capacity, ability and resources to enable them to render the required services. Such services will be handled as *ad hoc* and will be required from time to time.

7. THE PROSPECTIVE SERVICE PROVIDER SHALL RENDER THE SECURITY SERVICES AT UMZIMVUBU LOCAL MUNICIPALITY FACILITIES OR SITES AS FOLLOWS:

- 7.1 Protection of Umzimvubu local municipality employees, information and assets against any damages, injuries, vandalism, theft, sabotage, death and any other security risks or threats.
- 7.2 Daily execution of access and egress control in terms of the provisions of the Control of Access to Public Premises and Vehicles Act, 1985 (Act 53 of 1985).
- 7.3 Patrol and safeguard the Umzimvubu local municipality's premises and buildings.
- 7.4 Record all visitors and vehicles entering and leaving Umzimvubu local municipality premises.
- 7.5 Control the presence of persons, goods and vehicles and the movement thereof to and from the Umzimvubu local municipality facilities.
- 7.6 Conduct searches on employees, councillors and visitors entering and leaving the premises.
- 7.7 Compile reports of incidents of security breaches taking place during shifts operations.
- 7.8 Execute an arrest if there is a need.
- 7.9 Prevent any criminal acts including but not limited to malicious damage to vehicles, property and assets and if an incident has occurred, investigate it and report to the Umzimvubu local municipality management representative.
- 7.10 Carry out lawful security orders/instructions issued by the Umzimvubu local municipality's representative from time to time.
- 7.11 Record and safekeeping of all mail, documentation and official parcels delivered to the Umzimvubu local municipality's office/facility after office hours.

- 7.12 React and report the emergency situations to the relevant emergency services, e.g., ambulance services, fire department, police station and the Umzimvubu municipality's representatives immediately when the emergency occurs.
- 7.13 Ensure that security registers are always neat and up to date.
- 7.14 Report any lost and found articles/items to the supervisor and to the Umzimvubu local municipality's representative.
- 7.15 Locking and unlocking of Umzimvubu local municipality's facilities where there is a need and when authorised to do so.
- 7.16 Comply with the Occupational Health and Safety Act and Regulations (Act 85 of 1993).
- 7.17 Assist with the management of access control during the execution of evacuation procedure in consultation with the Umzimvubu local municipality's emergency team.
- 7.18 Ensure compliance with provisions of Firearm Control Act, 2000 (Act 60 of 2000) in respect of all Umzimvubu local municipality facilities being fire-arm free zones.
- 7.19 Attend to fire alarm panel and in case of fire take appropriate action when necessary.
- 7.20 Respond to ICT server room temperature alarms and take appropriate action as outlined by Umzimvubu local municipality emergency procedures where necessary.
- 7.21 Sensitisation / orientation of Umzimvubu local municipality employees in respect of the operation of building protection systems (for example sprinklers, fire detection, alarm, *et cetera*) installed in the buildings where the Umzimvubu local municipality is the owner or tenant.

8. GENERAL TERMS AND CONDITIONS

 - 9.2 The prospective service provider's administrative section must contain all equipment which are reasonably necessary for the effective management and administration of the security business, i.e. an operational landline telephone communication, which includes a reliable facility to receive and transmit facsimiles, computer equipment, photocopier and the office must contain a hard copy and/or electronic filing system for the orderly keeping of all records and documents (staffing and appropriate equipment).
 - Furthermore, the prospective service provider must have all the necessary equipment, including vehicles, as well as uniforms, clothing and equipment that must be issued to its security officers in view of the nature of their functions, at its disposal to enable it to render a proper security service.
 - 9.3 The prospective service provider must have at his/her disposal enough registered and appropriately trained and skilled security officers for the rendering of the required services. The security officers used for purposes of these services must be properly controlled and supervised.

- 9.4 The prospective service provider must have at its disposal enough adequately skilled administrative staff members for the purpose of the tender and for purpose of administrative affairs with regards to PSIRA regulations.
- 9.5 The prospective service provider must have at its disposal the financial means to ensure payment of the lawful remuneration/wages to its staff, as well as to ensure compliance with all other statutory financial obligations.
- 9.6 The operational standard of the infrastructure and capacity requirement will be subject to a due diligence audit by the Umzimvubu local municipality prior to awarding the bid.
- 9.7 The prospective service provider may be expected to work and co-operate with other service providers. It may be further required for the successful service provider to establish and maintain sound working relationships and procedures with other contracted service providers of the Umzimvubu local municipality such as surveillance camera service providers etc.

10. PROVISION OF SECURITY EQUIPMENT/AIDS AT SITES

The service provider shall make a provision of the standard security equipment to the security officers rendering security service at the Umzimvubu local municipality premises or facilities. The following security equipment must be provided to security officers on duty:

- Operational portable two-way radios and/or press to talk (PTT) or any other suitable communication equipment that is fit for purpose that is in line with acceptable communication equipment and procedures in the security industry.
- Operational LED torches
- Visitors' registers
- After hours register
- Handcuffs
- Batons
- Firearm (handgun) where needed by the employer
- Metal Detectors
- Acceptable pepper sprays
- Special equipment and Tools: Push to talk radios, metal detectors etc.
- Proof of ownership of security vehicles: certified copy of Disc/ logbook/s lease
 Agreement
- Active/valid Public Liability Cover insurance.
- Proof of firearms ownership: 30-40 proof of firearms ownership

9. PROVISION OF SECURITY OFFICERS ON SITES

9.1. The definitions of the various security officers' grades are as defined by section 41 to 44 of Basic Conditions of Employment Act, No 75 of 1997 (Sectorial Determination 6 – Private Security Industry Regulatory Authority of South Africa). As such, a security officer is defined to be any natural person who is employed by another person including an organ of state and who receives or entitled to receive from that person a remuneration, reward, fee or benefit, for rendering one or more security services, who renders security service under the control of another security service provider, and who receives or is entitled to receive from such other security provider, any remuneration, reward, fee or benefit for such service. or who or whose services are directly or indirectly made available by another security service provider to any other person, and who receives or is entitled to receive from any other person any remuneration, reward, fee for benefit for rendering one or more security services. Security officers are graded A, B, C and D

- 9.2. The Umzimvubu local municipality, for purposes of this bid, only utilises Grade A, B and C officers and the Umzimvubu local municipality does not, for the purposes of this tender, utilise any security officers on Grade D.
- 9.3 The prospective service provider shall, in order to ensure the continuity of the service to be rendered, allocate specific personnel to the specific site by the time the bid is awarded. A list of officers must be made available to the Umzimvubu local municipality.
- 9.4 Exchange or rotation of security officers on sites may only be made with prior consent of the Umzimvubu local municipality, Citizen & Community Services Department or Umzimvubu local municipality representative responsible for the facility.
- 9.5 The Umzimvubu local municipality reserves the right to interview security officers who will be rendering the security services at its sites before they commence with their work. The purpose of the interview is to determine the level, and suitable security knowledge of the security officers who are to be placed at Umzimvubu local municipality facilities.

10. MINIMUM WAGE

The prospective service provider must pay his/her employees the minimum monthly basic salary, as prescribed by the Basic Conditions of Employment Act, No 75 of 1997, Sectoral Determination 6 and the compliance of Private Security Industry Regulatory Authority (PSIRA) thereof. The prospective service provider's pricing costs on this bid must not be below the PSIRA costs requirements.

11. UNIFORMS AND IDENTIFICATION OF SECURITY OFFICERS ON SITE

The service provider shall ensure that each security officer will always, when on duty, be fully dressed in:

- 11.1 A neat and clearly identifiable corporate uniform which must be provided by the service provider. The uniform must include raincoats for personnel performing security duties in inclement weather.
- 11.2 A clear security or appointment card with photo which must be always worn conspicuously on him/her.

NOTE: No combat/camouflage uniform is allowed in a corporate office environment. Service providers will be advised when a combat, camouflage / body armour uniform may be required.

12. SERVICE PROVIDER RESPONSIBILITIES

- 12.1 Oversee all security activities performed by security personnel on Umzimvubu local municipality sites.
- 12.2 Handle all problems and challenges experienced by security officers on sites.
- 12.3 Attend to all problems regarding security personnel wages, family and any other problems.
- 12.4 Ensure that there is always security equipment on sites according to the contract.
- 12.5 Ensure that security officers on sites are suitably trained to the required level and competent to render the security services.
- 12.6 Liaise with Umzimvubu local municipality's representative and Citizen and Community Services Department on site.
- 12.7 Shortages and late coming by security officers must be recorded in the occurrence book and the Umzimvubu local municipality shall reserve the right to keep its own records on such incidents.
- 12.8 Ensure that security personnel are familiar and knowledgeable regarding the handling of emergency situations.
- 12.9 Ensure that security registers are legible, neat and updated always.

- 12.10 Ensure that all security officers understand the needs and expectations of primary clients (employees) and secondary clients (visitors).
- 12.11 Ensure that adequate security officers are placed on site as per contract.
- 12.12 Ensure that security officers shall not erect or display any sign, printed matter, painting, nameplates and advertising articles on any Umzimvubu local municipality's premises or building walls.
- 12.13 Remove any security officer from the site on request from an Umzimvubu local municipality representative.
- 12.14 Provide the Umzimvubu local municipality's representative with reasonable access to the designated service provider management to ensure efficient provision of services.
- 12.15 Provide the Umzimvubu local municipality's representative/Citizen and Community Services

 Department with monthly reports, attend monthly meetings and attend to all *ad hoc* meetings as requested by the Umzimvubu local municipality representative.
- 12.16 Provide shift rosters with the appropriate security officer's names and PSIRA grades to Umzimvubu local municipality officials when requested.
- 12.17 Conduct regular inspections on site.
- 12.18 Make himself / herself available during emergencies and telephonically contactable at all times.
- 12.19 Ensure that security officers are not involved in any illegal acts at Umzimvubu local municipality sites.

13. SECURITY INSPECTIONS

The Umzimvubu local municipality's officials reserve the right to conduct security inspections/audits on any of the Umzimvubu local municipality's facilities where the security officers are placed or posted to execute their security duties and to conduct inspection on the security personnel, security registers, records and equipment/aids as it may deemed required.

14. SHIFT DURATION

- 14.1 Shift duration of security officers shall be limited to a maximum of twelve (12) hours on all premises occupied by the Umzimvubu local municipality.
- 14.2 No security officer may work for more than forty-eight (48) hours in any seven (07) day cycle, unless if there is arranged overtime with the employee. (Please refer to Basic Conditions of Employment Act, No 75 of 1997, as amended. Sectoral Determination 6 Clause 5, sub clause [2] (a), (b), (c). The Umzimvubu local municipality shall not enter or entertain any negotiations regarding this requirement.

15. RESOURCES AND FACILITIES PROVIDED BY THE UMZIMVUBU LOCAL MUNICIPALITY

The Umzimvubu local municipality will make the following facilities available to the prospective service provider:

- 15.1 Toilet/ablution facilities.
- 15.2 Service provider's security control room to run 24/7 in order to be able to receive emergency calls from securities on sites and be able to make immediate contact to the police, fire brigade, Umzimvubu local municipality's Citizen and Community Services Department and the contracted alarm monitoring service provider.
- 15.3 Umzimvubu local municipality security site instruction or any security related manual or document.

- 15.4 Training in respect of fire detection and evacuation systems, where necessary.
- 15.5 Provide electricity
- 15.6 Provide water and sanitation
- 15.7 Provide guard room

16. WRITTEN PROPOSAL

It is a requirement of this bid that a written proposal/submission be made by the prospective service provider covering the following aspects:

- **16.1** Provide company profile and organogram. Names of incumbents must be appropriately stipulated on the organogram with CV and attachment of formal qualifications in security risk management, if are there any.
- 16.2 Provide detailed description of the company's similar and related experience and track record. Submit a detailed list of existing and previous client's appointment letters in client letterheads stipulating also the contract amount.
 - 16.3 Established Administrative Office
 - The Prospective service provider must have a well-established immovable office (structure) for administration purposes and the office.

The administration office shall consist of the following aspects:

- 16.3.1 The office should consist of at least one room dedicated for this purpose.
- 16.3.2 The office must contain all the equipment which is necessary for the effective management and administration of the security services.
- 16.3.3 The office must have a landline, fax machine, electronic filing, et cetera.
- 16.3.4 It must be situated at a place that is reasonably accessible to the Umzimvubu municipality.
- 16.3.5 The office must be in a place which is accessible by the security officers that are used by the company to render security services.
- **NB**: Please indicate clearly in the written submission items in your office as stated on 16.3.1 to 16.3.5

16.4 Security Control Room

The prospective service provider must have a well-established immovable facility (structure) that serves as an equipped security control room with 24-hour operational service for the purpose of reporting and provision of assistance in cases of emergency. The security control room shall be always manned for 24 hours. The security control room must be within the Umzimvubu local municipality jurisdiction and the communication from the control room must be within reach to Umzimvubu local municipality sites.

As a minimum requirement a control room shall have the following equipment in operational state:

- 16.4.1 Facsimile machine on a direct landline.
- 16.4.2 Telephone on a direct landline.
- 16.4.3 At least one operational cellular phone.
- 16.4.4 LED torch.
- 16.4.5 Operational radio-base and two-way radio communications and/or (Push to Talk) PTT.
- 16.4.6 Installed secure security door at the control room entrance.

- 16.4.7 Contact numbers of all managerial staff, client office and after-hours numbers, police, ambulance, fire brigade, *et cetera*, shall be permanently displayed on the control room wall.
- 16.4.8 Appropriate and trained security officers manning the control room on 24-hour basis.
 - **NB**: Please indicate clearly in the written submission items applicable in your control room as stated on 14.4.1 to 14.4.8
- **16.5** The prospective service provider's written proposal must include the details of the proposed team which will assist with administration and rendering of the security services to the Umzimvubu local municipality. This team should include and not be limited to:
 - Operational Manager
 - Supervisor/s
 - 16.6 Provide the curriculum vitae (CV) of each team member as proposed on 14.5. The details should include CV's, copies of their IDs, PSIRA qualifications (Certificates), knowledge and experiences of the members. The security experiences of the incumbents must be detailed in the CV.
 - 16.7 Provide detail proposal or project plan on how the prospective service provider will provide the capacity, equipment and security services for the duration of the contract. The project plan must provide details on how the project will be executed and it must include and limited to the following aspects:
 - How the prospective service provider will protect and safeguard the assets and employees.
 - How the service provider will provide capacity, human resources and assets to provide to execute the plan.
 - How the service provider will prepare for the taking over of the site.
 - Patrol system or mechanism for the Umzimvubu local municipality facilities/sites.
 - The provision or deployment of security officers on the sites.
 - Liaison and reporting to the Umzimvubu local municipality representative.
 - Any other areas/issues which may improve the security services at sites.

16.8 Provision of contingency plan for labour unrest and strikes on site

When the security service is interrupted or temporarily deferred because of any labour unrest, labour disputes, civilian disorder, a local or national disaster or any other cause, the service provider must ensure the activation and implementation of contingency plans until full and normal service is restored. The service provider must ensure that the company responds to the emergency in less than three (3) hours.

NB: The prospective service provider is required to provide a convincing contingency plan to illustrate how it would ensure the safeguarding of the Umzimvubu local municipality facilities and employees in the event of/or any labour unrest and strikes by either security officers or employees of the Umzimvubu local municipality.

16.9 The prospective service provider must provide a detailed plan on how the *ad hoc* services will be arranged and implemented throughout the contract. The prospective service provider's *ad hoc* plan must provide details on the following aspects:

- How would the prospective provider arrange for the required ad hoc services?
- How much time will the service provider need to arrange the required service?
- How will the prospective service provider cover the required sites?
- Provide the details on how resources will be made available for ad hoc services?
- Indicate how the ad hoc will be managed and who will manage such services?

17. PSIRA REQUIREMENTS

- 17.1 The company or close corporation and every director of the company or member of the close corporation must be registered in terms of Section 20 of the PSIRA Act 2001 (Act 56 of 2001).
- 17.2 The prospective service provider's rates and costs must be in line with the minimum PSIRA requirements.
- 17.3 The prospective service provider must provide the PSIRA registration certificate.
- 17.4 Prospective service providers must provide an original or copy of the written letter of good standing from PSIRA. This correspondence must be valid at the bid closure date. The service provider may be required to submit a valid original or certified copy of the letter of good standing at any given time during for the duration of the contract.
- 17.5 All security officers in the employ of the company or close corporation must be registered PSIRA.
- 17.6 All security officers supplied by the company or close corporation must be trained to the standards set out and regulated by PSIRA and by a training centre accredited by PSIRA.

18. MONTHLY INVOICING AND PAYMENT

Monthly payments will be made in accordance with the general conditions of contract and the invoicing must be done in accordance with the following procedure:

18.1 Only original invoices accompanied by a monthly report will be accepted for payment.

19. ANNUAL INCREMENT (Very Important)

NB: Annual increases and Value Added Tax (VAT) must be included in the tender price.

20. ADDITIONAL / AD HOC SECURITY SERVICES

Due to security operational requirements within the Umzimvubu local municipality, additional security services may periodically be required on an *ad hoc basis* such as during emergencies, events etc.

Requests for additional security services shall be handled as follows:

- 20.1 The Umzimvubu local municipality shall in advance request confirmation from the contracted service provider to establish its capacity and ability to render the required additional services at the time that the service is needed. The prospective service provider shall be expected to have capacity to provide *ad hoc* / additional security services. Prospective service provider's confirmation shall also include a detailed security plan and dedicated team with a manager when necessary.
- 20.2 The contracted service provider shall provide the Umzimvubu local municipality with a quotation for the required ad hoc services.

- 20.3 The Umzimvubu local municipality shall assess the service provider's confirmation for the rendering of additional security services before acceptance.
- 20.4 The Umzimvubu local municipality shall have the right to engage alternative service provider/s through competitive bidding in cases where the contracted service provider:
 - Confirms that it does not have the capacity or ability to render the required ad hoc services.
 - The quotation is not in compliance with the PSIRA requirements.
 - The quotation is not market related.
 - The services cannot be adequately provided.
- 20.5 Payment for such services will be calculated separately from the normal guarding services and will be subject to the provision of accepted quotations prior to engagement of such services and proof that the services were rendered as required.
- 20.6 The security officers provided for the event may be subjected to security screening or vetting by the State Security Agency (SSA) as may be required.

21. DURATION OF THE CONTRACT

A Service Level Agreement (SLA), based on this tender requirement, will be entered into prior to the commencement of a service provider. The SLA (contract) will be valid for a period of **two (2) years** from the commencement date provided that the service provider maintains compliance with all the tender conditions and requirements during the period.

22. COMPLETION OF PRICING

General Conditions of Contract

- **1. Definitions** 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the Bid documents for the receipt of Bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any Bidder, and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive the Bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is.
- 1.16 "Imported content" means that portion of the Bid price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his sub SERVICE PROVIDERs) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the Bid will be manufactured.

2. Application

- 2.1 These general conditions are applicable to all Bids, contracts and orders including Bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the Bid documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the Bid documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a Bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to Bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards

4.1 The goods supplied shall conform to the standards mentioned in the Bid documents and specifications.

5. Use of contract documents and information inspection

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall **GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY:**Republic of South Africa 6 extends only so far as may be necessary for purposes of such performance.
- The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain he property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- The supplier shall permit the purchaser to inspect the supplier's records relating to the Performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent Rights

- The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful Bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the Bid documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified. **GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa** 7

8. Inspections, tests and analyses

- 8.1 All pre-Bid testing will be for the account of the Bidder.
- 8.2 If it is a Bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the Bidder or SERVICE PROVIDER's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.
- 8.3 If there are no inspection requirements indicated in the Bid documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. 10. Delivery and documents

10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental Services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:
 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: **GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa** 9 (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve

the supplier of any warranty obligations under the contract; and; (b) in the event of termination of production of the spare parts: (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.

- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract. GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa 10
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his Bid, with the exception of any price adjustments authorized or in the purchaser's request for Bid validity extension, as the case may be.

18. Variation orders

18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the SERVICE PROVIDER may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the SERVICE PROVIDER may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the Bid. Such notification, in the original Bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its sub SERVICE PROVIDER(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, it's likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available. GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa 11

- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and

up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess posts for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.

- 23.5. Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Bid Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website **THE NATIONAL TREASURY: Republic of South Africa**

24. Antidumping and countervailing duties and rights

24.1 When, after the date of Bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
 - 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
 - 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party. **GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa**
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
 - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of Liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
 - (a) the supplier shall not be liable to the purchaser, whether in
 - contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices

- 31.1 Every written acceptance of a Bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his Bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT THE NATIONAL TREASURY: Republic of South Africa
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any Bidder whose tax matters are not in order. Prior to the award of a Bid SARS must have certified that the tax matters of the preferred Bidder are in order.
- 32.4 No contract shall be concluded with any Bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts

The SERVICE PROVIDER shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts

34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of **restrictive practices** 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a Bidder(s) is / are or a SERVICE PROVIDER(s) was / were involved in collusive Bid.
- 35.2 If a Bidder(s) or SERVICE PROVIDER(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 0f 1998.

35.3	If a Bidder(s) or SERVICE PROVIDER(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the Bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the Bidder(s) or SERVICE PROVIDER(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the Bidder(s) or SERVICE PROVIDER(s) concerned.
