- 10 The Model Preambles for Trades 2008 Edition as published by the Association of South African Quantity Surveyors will apply to this contract.
- 12 The "FORM OF CONTRACT FOR HOUSING AND MINOR WORKS" will be used for this project, JBCC or GCC
- 13 All Prime Cost amounts and Provisional Sums are nett. No discount will be allowed to the Contractor. Note: All sub-contractors are direct contractors to the main contractor.
- 14 Where applicable and unless otherwise described, all rates must include for the necessary scaffolding not exceeding 5m high above bearing level AND also for dust screens & tarpaulins etc. where required
- 15 All rates must include for the necessary cutting & waste.
- 16 Profit and Attendance will be adjusted in direct proportion to the final amounts.
