SPECIFICATION FOR ERECTING STEEL STRUCTURE FOR
GREEN HOUSE HAIL PROTECTOR C9 2022

Size L x B x H

26 x 10 x 5 = 1300 m

Shade net roofing 10% (10% of shade; 90% sun going through)

Size of steel will discuss on the site visit. Galvanized steel must be used.

Similar hail structure like C10 green house. Hail net similar to C17

It is a compulsory to attend a site visit

SAFETY:

- A working scheme shall be prepared before the commencement of the erection. It shall also contain rules for safety precautions
- The anchor bolts used for the fastening of steel structures shall be set in a designed position and grouted along with foundations
- The grouting shall be done after the verification and proper positioning of the structures but before encasing the structures with concrete if specified
- If the work involves flame-cutting, burning, heating, riveting, or any operation that could start a fire, a fire protection procedure must be set up
- The workers should be strictly instructed not to throw objects like hot rivets, cigarette stubs, etc. around.
- A sufficient number of fire extinguishers of soda acid type shall be placed at designated points.
- Extinguishers must be placed in cranes, compressors, hoists, and similar places.
- In places where electrical equipment is involved, instead of soda acid type, CO₂ or dry powder extinguishers shall be provided.
- Any damaged to structural or glass panels shall be examined and rectified or replaced
