Any tender submitted by a person(s) who is in the service of the state or if that person(s) is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state or who is an advisor or consultant contracted with the Municipality shall not be considered in terms of regulation 44 of the Municipal Supply Chain Regulations. Only suppliers who are registered on Central Supplier Data Base (CSD, visit the CSD website at **www.csd.gov.za**) can apply for this tender. All suppliers applying for this tender must register on the Municipal database.

Prospective service providers are required to ensure full completion and correctness of information when responding to MBD 4 and all other required declarations in the document. The Municipality reserves the right to validate the correctness of the declarations through various databases inclusive of the Central Supplier Database (CSD).
