The contract for upgrading the sports facility in **Eksteenfontein** comprises of the following:

- Refurbishment of existing combination sports court
- Upgrading of existing fence at the combination sports court

The contract for upgrading the sport facility in **Lekkersing** comprises of the following:

- Construction of one (1) combination sports court
- Upgrading of diamond wire fence (250m x 2,1m high)

It is estimated that tenderers should have a CIDB contractor grading designation of **3 CE** or higher.

The closing time for receipt of tenders is **Friday, 8 August 2025 at 12H00**. Bid documents must be deposited in the bid box situated at the municipal offices, 169 Main Road, Port Nolloth. Late bid submissions will be not considered. Bids will be evaluated in accordance with the applicable Preferential Point Scoring System as set out in the Councils Supply Chain Management Policy. The following forms: **MBD1, MBD 4, MBD 6.1, MBD 6.2, MBD 8, and MBD 9** must be completed and submitted with the bid. The Municipality reserves the right not to award the tender to the only or the lowest Tenderer. Tenders may only be submitted on the tender documentation that has been issued.

*The following tender conditions will be applicable:*

- Faxed, e-mailed or late Proposals will not be accepted.
- The tender will be evaluated on 60/20 system where 60 points for price and a maximum of 20 points for specific goals. To claim for specific goals prospective bidders MUST submit proof of the required documents.
- No tender offer will be considered from the following tenderers: Persons who were convicted for fraud or corruption during the past five years. Who wilfully neglected, reneged on or failed to comply with a government contract during the past five years
- Tenderers must submit a valid Tax Clearance Certificate or SARS PIN.
