<p>Building of a new Cryo laboratory at B2 Genebank building that attaches to the existing building.</p> <p>Brick building, plastered and painted to match existing building. Roofing, windows and doors must match existing building as well. Double exit doors will need to be added on two sides of the laboratory. A ramp will need to be built leading up to these two doors.</p>	1	ea
<p>Drop-in Sink & Water connection & Plumbing</p> <p>New laboratory will require a drop-in laboratory sink installed together with water connection and associated plumbing.</p>	1	ea
<p>Fitting of Storage Cupboards & Granite Workbenches</p> <p>The laboratory will need to be fitted with customised storage cupboards (white melamine) and granite top workbench (black Rustenburg).</p>	1	ea
