1. PURPOSE

- Request for a service provider to be sourced to conduct **Women empowerment Workshop**. The Training will take place in Pietermaritzburg for **80 officials** from levels 11 – 15. (Deputy Directors- 46 and Directors-34).
- This workshop is targeting Deputy Directors and Directors in order to transform the Departments in terms of the Employment Equity Act towards equality between women/men, LGBTIQA+ and persons with disabilities.

2. SCOPE OF WORK

The scope of work must cover all important aspects in respect of the Women Empowerment aligned with the relevant Public Service Frameworks.

- Highlighting the Women Empowerment and Gender Equality (WEGE) and disability concepts used in the Mainstream Agenda.
- Aligning the programmes/ projects and policies of the Department with the International, Regional and Sub-Regional treaties and conventions on gender and disabilities.
- Identifying the gender and disability gaps in the Department and recommending remedial actions to be identified to close the gaps.
- Identifying the needs, concerns, interests and rights of women and persons with disabilities in the workplace through the policies, programmes and projects of the Department.
- Analyzing policies/ programmes and projects in the Department for gender and disability mainstreaming.
- Providing guidelines on the implementation of the 8-Principle Action Plan on Gender Equality and Women Empowerment as required by the DPSA Tool.
- Implementing Gender and Disability Responsive Planning, Budgeting, Monitoring, Evaluation and Auditing for all the programmes of the Department.
- Highlighting gender and disability as imperatives for the Developmental State and the National Development Plan 2030 plus the Sustainable Development Goals.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
