

## SUPPLY AND DELIVERY OF LED LIGHTS AT ROSHERVILLE SCOPE OF WORKS

## **Background**

As Property admin Services we have an obligation to ensure that all facilities within Rosherville farm are always compliant. Quarterly assessment was conducted where it was identified that some facilities are not compliant according to building regulations and compliance. Hence the need to procure the LED lights there after PAS personnel will install.

The scope is outlined below.

#### **Scope**

The scope is to supply and deliver the following material as per the clients need:

- LED T8 18W Cool white Flourascent tube (4Ft).
- LED T8 22W Cool white fluorescent tube (5ft).
- ❖ Pioled Combat T5 18W cool white Fluorescent tube.
- ❖ Lamp LED 36W cool white Fluorescent tube (8Ft).
- ❖ Lamp LED GU10 5W down light.
- ❖ LED 100W GES Cool white lamp.
- ❖ LED 200W light fitting.
- LED 200W light fitting complete with Solar panels.
- ❖ AIO Solar LED Complete with battery Backup.

# **Logistics and Delivery to Site**

- All the test certificates and other supporting documents related to LED lights and fittings specifications must be made available.
- Eskom Rotek Industries quality management QM58 must be adhered to.
- Requirement for Electrical Fittings must be adhered to as per the standard and SANS Code 9001- 2015-ED5.
- All Equipment/ material shall be protected as the case may be, carriage at site and outdoor storage during transit and at the site, strictly according to the instructions given in this specification.

- The supplier shall be responsible for any damage to the equipment and or fittings during delivering Bundled materials shall be strapped rigidly with steel band over the protective covering.
- Fragile materials shall be securely braced within the containers or otherwise amply fastened and packed to prevent shifting or rattling.
- Soft non-hygroscopic packing materials shall be placed between the hard packing materials and the fragile Equipment.

# **COVID 19 compliance**
