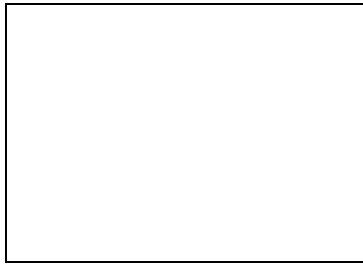

CERTIFICATE OF INDEPENDENT BID DETERMINATION
