#### **SCOPE OF WORK**

The Bid Specification Committee prepares the scope for the project of work as follows:

##### **Key Performance Areas**

- Cleaning of illegal dumping sites by means of litter picking and garden waste picking through manpower. No TLB will be hired.
- Litter picking and maintenance of cleanliness in all streets and open spaces.
- Ensure maintenance of clean street such that there is no litter or any other general waste material.
- Waste collection – both campaign and routes
- Ensure that waste collection and loading including the normal household refuse.
- Maintenance of general cleanliness at community leisure parks.
- Litter picking and street sweeping
- Waste removal and loading
- Conduct environmental education and create environmental awareness in all below stated areas of operation.
- Conduct door to door campaign and educate members of the public about best waste Management practices.
- Create awareness by discouraging littering and dumping
- Support the municipality during environmental awareness campaign
- Conduct cleaning services for six days a week including cleaning Ngqamakhwe CBD Over the weekends

#### **Contract Period**

The contract period is 36 months' (03 Years) from date of award/order
