**RFQ 27 of 2023: APPOINTMENT OF A SERVICE PROVIDER FOR THE DEVELOPMENT OF
TRADITIONAL (PHYSICAL) INVENTORY, DIGITAL INVENTORY, STORAGE ASSESSMENT, AND
PROVENANCE SERVICES FOR THE NELSON MANDELA MUSEUM COLLECTION HERITAGE
AND CONSERVATION UNIT**

1. PURPOSE

To invite suitably qualified service providers to submit quotations for the compilation of the traditional and digital inventory, valuation report, conservation assessment, and provenance research services for the Nelson Mandela Museum Heritage Unit Collections.

2. BACKGROUND

The Nelson Mandela Museum (NMM) is an agency of the National Department of Sport, Arts, and Culture established in February 2000. It is mandated to conserve, preserve and manage a collection of gifts, presents, and awards bestowed to its founding Icon Dr Nelson Rolihlahla Mandela.

The Museum works primarily in two sites; Bhunga Building in Mthatha and Qunu Youth and Heritage Centre in Qunu. Bhunga Building is where the historical collections are preserved and exhibited for museum patrons, national and international. The NMM has a strong footprint in historical areas like Mvezo, Mqhekezweni, Qokolweni, and Clarkebury. For the benefit of futures generation, the museum is responsible for providing content related to all its collections in a manner that complies with international standards.

To achieve its objectives, the museum must comply with section 39 of the National Heritage Resources Act No 25 of 1999, which requires that the South African Heritage Resources

Agency must compile and maintain an inventory of the national estate (a database of information on heritage resources worthy of conservation). In 2018, the South African Heritage Resources Agency (SAHRA) identified the NMM collections as worthy of declaration as a national estate. This declaration is subject to meeting the required standards set in the National Heritage Resources Act No. 25 of 1999. Collections must be well preserved and conservation practices in place and be traceable through a well-maintained inventory. These demands make it necessary to have this collection well preserved, and well stored with an up-to-date inventory of the collections of the national estate of heritage resources in the Republic of South Africa.

Before declaring this collection, SAHRA will conduct an audit of all collections of the object the NMM is housing in its Bhunga Building site, where almost 4000 collections are housed and exhibited. The NMM is an entity that is expected to also comply with the GRAP103 prescript. This prescript requires that heritage assets must be valued and reported under the annual financial statements of the Museum

The about 4000 collections in the museum include artworks, photographs, letters, fabrics, percaline, glasses, wooden artwork, steel artwork, and various gift materials. All these gifts were given to Nelson Mandela, mostly after his release from prison in February 1990. These are gifts from individuals, governments, business sectors, academics, children, celebrities, and many different spaces nationally, in the continent, and abroad.

This request for a quote will serve as an intervention to meet the compliance requirement for collections to be officially declared by SAHRA as advised since 2018. These include an up-to-date inventory (traditional and digital), conservation assessment (storage), and assessments of objects (damage report) This project will also prove an opportunity to ensure that the NMM is among leading institutions in the province (eastern Cape) with the objects within SAHRA's ownership, objects that are known, well preserved and managed in accordance with the best practice.

3. SCOPE OF SERVICES

THE SERVICE PROVIDER WILL BE REQUIRED TO PERFORM THE FOLLOWING DUTIES:

3.1 Interview key stakeholders to ascertain object provenance and identify

- 3.2 Visit the NMM Bhunga Building to assess and provide recommendations/list of requirements to create a space in the storage
- 3.3 Train Heritage Unit officials on the management and handling of heritage objects
- 3.4 Perform archival research to verify ownership of the objects
- 3.5 Compile an inventory of the objects associated with the NMM to ensure compliance as required by the standard SAHRA object template, including the current location of each of the objects
- 3.6 Tag and label each object – tags to be supplied to the successful service provider
- 3.7 Conduct a condition and conservation assessment of each object
- 3.8 Photograph each object in accordance with the following requirements
 - a) Photographs should be taken in digital format.
 - b) For 2-dimensional artworks (e.g. paintings, drawings, and prints), the photograph should be taken directly in front of the work showing it in full. If the work is framed, a second photograph should be taken showing the frame.
 - c) When the artwork is under glass, there must be no reflection visible; if necessary, the glass must be removed before photography. For 3-dimensional work (such as sculpture), photographs should be provided from at least three different angles giving a full view of the object. If the sculpture has a base, it should be shown in one of the photographs.
- 3.9 Capture the information of each object (Including photographs)

- A detailed cost proposal, inclusive of travel and accommodation in Mthatha. The service provider must reflect a detailed account of the fees inclusive of VAT

7.2 Price (VAT included)

80 Points for price will be awarded with reference to the total fixed proposal amount inclusive of VAT. The service provider with the lowest price shall score the maximum 80 points.

7.3 The adjudication of proposals will be conducted in terms of the following Scoring System:

- a) Team members Professional experience in Collections management (30 Points)
- b) Team members Professional experience in conducting object based research for provenance (25 Points)
- c) Team members Knowledge and experience in the formulation of conservation management plans (25 Points)
- d) Record of similar projects undertaken (20 Points)

Bidders must score a minimum of 65 points in total for functionality in order to be evaluated for "Phase 2: Price and Preferential Procurement".
