

1. INTRODUCTION

- 1.1** The Department of Public Works and Infrastructure (DPWI), herein referred to as the "Department," seeks Aerial Surveillance Services to assist with the illegal occupation at Knoflokskraal, Grabouw.
- 1.2** The purpose of these Terms of Reference (ToR) is to outline the role and responsibilities of aerial surveillance services that assist with the land and security information of the illegally occupied state land, Farm 335 Knoflokskraal, Farm Charleskloof No. 336, Farm Haasvlakte No. 445, Farm Trek Pad No. 330, Farm New Forest No. 334, Farm De Rust No. 328, and Farm 440 Koffe Kraal, situated in the Caledon Registration Division known as Knoflokskraal, Grabouw.

2. BACKGROUND
