1. BACKGROUND

The City of Tshwane (the City) secures development funding for its infrastructure program in the form of municipal bonds and bilateral loans.

All bilateral loans that the City raised to date were secured by running a competitive procurement process. The process mainly involved bidders from South African commercial banks and the local development finance institution being the Development Bank of Southern Africa (DBSA). One of the areas covered during the evaluation process relates to comparing interest rates and other costs attached to the proposed funding by various potential lenders.

As the money manager and in-house banker to the City, Treasury Division performs the financial risk management function within the City and looks after the City's liquidity and interest rate risks. Effective management of the stated risks requires Treasury Division to conduct, on a regular basis, valuation of financial instruments, particularly interest rate swaps that the City put in place over the years to mitigate interest rate risk associated with its long-term funding. Currently, the City has several bilateral loans and municipal bonds and more than nine interest rate swaps in its books.

Cash flow management has become increasingly important following the Covid 19 pandemic and lately with a growing consumer inflation rate mainly caused by the ongoing war between Russia and Ukraine. Improving the City's cash flow position has been challenging despite the City pursuing aggressive revenue collection effort. The kind of challenges such as the Covid pandemic require the City to rigorously employ stress tests and scenario analysis to assess the impact of major stress events on the City's liquidity situation. It is due to this that the City would like

to have access to a robust financial model that will be used in stress testing its cash flow position.

Extension of validity shall be finalised while the quotations/bids are still valid.

8. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, Where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tender if they will be able to deliver on the price, if a tenderer confirm that they cannot, The tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the Quotation.
