## SCOPE OF WORK

#### 1. PURPOSE

The purpose of this bid is to appoint an additional panel of suitable service providers to transport people from various location within the Nkangala District Municipality for a period of three (3) years (as and when required).

### 2. BACKGROUND

Local government as a sphere of government closest to the people should interact with communities in to carry the responsibilities of service delivery to ensure growth and development in a manner that promotes and enhances community participation and accountability, therefore the transportation of community members from their juristic areas to the place of meeting with the community political leader must be provided for by the appointment of a panel service providers for transportation services.

#### 3. SCOPE OF WORK

The Municipality requires the services of suitably qualified service providers to, inter alia:

- Provide suitable vehicles with valid operation licenses to transport community members to various destinations.
- To ensure that safe and reliable service standards are met through the use of appropriate modes of transport in terms of quality and quantity.
- The routes and destinations will be made available to the service providers as and requested to render the service.
