T1.1 : TENDER NOTICE AND INVITATION TO TENDER

Tenders are hereby invited for contract no: NC065/T07/2025 for the upgrading of the second phase of the medium and low voltage networks in Brandvlei for Hantam Municipality.

Only bidders who satisfy the eligibility criteria stated in the Standard Conditions of Bid (Clause C.2.1) are eligible to submit tenders.

Tenderers must be registered with the CIDB in an **EP** class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading designation of **3EP or higher**.

Contractors registered as potentially emerging enterprises with the CIDB who are registered in one contractor grading designation lower than that required in terms of the requirement above and who satisfy all other Eligibility Criteria in terms of this Tender, may submit tender offers.

Tender Documents will also be available at the compulsory site inspection. Prospective tenderers need to inform Mr. Theo Potgieter should they require a printed document at the compulsory site inspection.

Duly completed tenders in sealed envelopes marked "TENDER NC065/T07/2025: UPGRADING OF THE MEDIUM AND LOW VOLTAGE NETWORK IN BRANDVLEI - PHASE 2", together with the name and address of the Tenderer must be placed in the tender box, Municipal Offices, 20 Dr Nelson Mandela Drive, Calvinia before 12:00 on **Friday 15 August 2025**, upon which the tenders will be made public.

A **compulsory clarification meeting** with representatives of the Employer will take place at the Municipal Offices of Hantam Municipality in **Brandvlei**, Main Street, Brandvlei on **Wednesday 23 July 2025**, at **11:00**.

Late tenders will not be accepted and the Municipality will not be compelled to accept the lowest or any tender. The Municipality reserves the right to omit any part of the tender, or to scale down on the scope of work for the contract amount to fit into the available budget. Tenders by telephone, facsimile and e-mail will not be accepted.

All bids received shall be evaluated in terms of the Hantam Municipality's Supply Chain Management Policy and Preferential Procurement Regulations. It is estimated that the 80/20 preference points system will be applicable. Tenders will be evaluated in terms of price and specific goals. Points will be allocated on the following basis : 80/20, where 80 Points for Price, 10 Points for Locality and 10 Points for The Youth.

Specific goals:

- **The Youth – 10 Points** (The Youth are identified as any person between the ages of 18-35 years as per the National Youth Policy of South Africa – Identification Document will be used to measure and allocate points by use of the company registration documents (CIPC) and the Central Supplier Database (CSD) documents to identify which director/s are identified as a Youth).
- **Locality – 10 Points** (Locality will be allocated as follows):

LOCALITY OF SUPPLIER	NUMBER OF POINTS FOR LOCALITY 80/20
Within borders of Northern Cape	4
Within borders of Hantam Municipality	6

(Both points will be claimed for physical office location within the borders of Hantam Municipality and Northern Cape which will amount to 10 points if office is within Hantam Municipality, only 4 points will be allocated for physical office location in the Northern Cape).

Points for specific goals MUST be claimed in paragraph 6.1. Bidders are also required to submit Proof of Locality in order to claim points for locality.
