GAUTENG PROVINCE: INVITATION TO THE NATIONAL LOTTERIES COMMISSION ENTERPRISE AND SUPPLIER DEVELOPMENT PROGRAMME 2022/23 FINANCIAL YEAR

1. Enterprise and Supplier Development Background

- 1.1 The National Lotteries Commission (NLC) is a public entity established by Lotteries Act No. 57 of 1997 as amended to regulate the South African lotteries industry. The functions of the NLC can be divided into two (2) categories, namely "regulation of National Lottery and other Lotteries" and "administration of the National Lottery Distribution Trust Fund (NLDTF)".
- 1.2 The NLC is committed to the transformation of the South African economy through the adoption of the Broad-Based Black Economic Empowerment (B-BBEE) Framework. It is this belief that drives the NLC philosophy behind sustainable procurement practices related to Enterprise and Supplier Development (ESD). For the financial year 2022/23, the NLC through SCM would like to partner with SMMEs companies through the ESD initiative in Gauteng.
- 1.3 The invitation is towards ESD, and the process entails working collaboratively with suppliers to improve or expand their capabilities. The ESD involves embracing supplier expertise and aligning its business needs towards empowerment. The NLC is in a process of identifying at least 2 possible ESD beneficiaries in Gauteng. The target appointment of ESD Beneficiaries in the Province as indicated in the above paragraph is as follows:

- 1.4 ESD Applicants are required to apply for the ESD Direct Support for not more than R 250 000.00 (Vat Inclusive) on each Initiative in the Province.
- 1.5 Where deemed necessary and possible, the NLC may split the direct support to more than the targeted number as indicated in the table provided in paragraph 1.3 above.

5. QUALIFYING CRITERIA TO THE PROGRAMME

The ESD Applicant must meet the following to be considered:

- Exempted Micro Enterprise (EME) (R10 million and less annual revenue) and Qualifying Small Enterprise (QSE)- annual revenue of between R10 million and R50 million) that are 51% or more black owned and 30% or more black women owned.
- 2. Members/shareholders of the company are black South African citizens.
- **3.** The company must be registered with CIPC and compliant with SARS. CSD Registration Report.
- 4. The ED/ESD beneficiary must not have committed to any ESD in the past two (2) years. The ESD Applicant to be disqualified should the NLC found out that the ESD Applicant has committed to any ESD in the past 2 years.
- 5. The company must be in operation for at least two (2) years; and
- **6.** The company must be fully based in South Africa and located in Gauteng.
- **7.** Registered business addresses of the company should be in the targeted Province (Gauteng).

- 7. The SD applicant must not have committed to any ESD in the past two (2) years.
- 8. The company must be in operation for at least twelve two (2) years from the closing date of ESD Submission.
- 9. The company must be fully operational and based in the Gauteng Province; and
- 10. The company must be fully based in Gauteng. Kindly attach proof of residence that reflect the Director's Name or Company Name in a form of Lease Agreement, Municipality Bill & Tribal Authority Letter/ relevant confirmation letter for residence from Local Community Leader.
