## **1. PURPOSE**

The purpose of this exercise is to appoint a service provider for the provision of writing, editing, and proofreading of the annual report for a period 3 years.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

### 3. SCOPE OF WORK

- Writing, Editing and Proofreading of the Annual Report for 3 years.
- A highly qualified writer, editor and proof-reader with fluent English language and communication skills who will describe the work of SANParks based on its three core pillars of Sustainable Conservation, Diverse and Responsible Tourism and Socio-Economic Transformation.
- Schedule and conduct interviews with relevant executives and senior management to understand the organisation's purpose, objectives, function and programmes to ensure that the report is accurate
- Write compelling, user-friendly and comprehensive content by drawing in on the interviews and on quarterly, strategic and other reports.
- Editing of and approximately 300 pages document
- Ensures that the document is edited and proof-read – ensure that document is grammatically correct, with no typos and spelling errors and the flows from a story perspective.
- Three rounds of editing
- Three rounds of proofreading
- Consolidation of reports from different business units into 1 final report
- Printing own copies of annual report for proofreading and sign-off supplied to SANParks
- Work closely with the appointed graphic designer to:
  - Structure the layout and flow of content
  - Translate and interpret raw numerical data into tables, graphs and infographics
  - Produce a document of exceptional quality and value to SANParks and stakeholders
- Note the draft copy and will be provided to the supplier by SANParks.
- Travel will be to the SANParks Head Office in Pretoria and costs much be factored into the quotation.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

    - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
    - (e) forward the matter for criminal prosecution, if deemed necessary.
