DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

The SABC Eastern Cape Offices, comprising Gqeberha, and East London buildings which requires the pest control and fumigation services ensuring that the company is aligned to OHS requirements and compliance.

The Pest Control Service will therefore assist in trying to maintain a pest free environment for all SABC Staff, contractors, and visitors to the SABC buildings in the region. This will also assist with adhering to the safety compliance hygiene and environmental regulation as per Agricultural and fertilizers Act 36 of 1947; OHS Act no 85 of 199 and Hazardous chemical substance Act 15 of 1973.

2. SCOPE OF SERVICES

The Service Provider will be required to provide a comprehensive Pest Control and Fumigation Service at the following areas:

2.1. GQEBERHA (PORT ELIZABETH) AREARS

- Entrance, foyers, reception area, lift, stairs, passages, kitchen, and canteen
- Offices and related areas, archives, video library, preview theatres, studio control rooms, dubbing studios and audio studios
- Toilets, bathrooms, rest rooms
- Stairs, TV/OB Offices, workshops, and garages
- Two maintenance workshops
- Fleet vehicle office
- Clinic and legacy Centre

2.2. EAST LONDON AREARS

- Entrances, Foyer area, reception area, stairs, passages, and kitchen
- Offices, Toilets, boardroom, equipment room and storeroom

2.3. Monthly Service and Maintenance which includes but not limited to the following:

- Respond to callouts as and when needed
- Issuing of treatment report on monthly basis to the Logistics Manager
- maintenance and control of rodent/ mouse/rat
- Termite extermination control;
- Maggot's control;
- Fly extermination and control;
- Maintenance/Fumigation/Pest Control of potential infestation areas; as and when required
- Disinfection of viral infected facilities (fogging) e.g., covid-19
- Removal of dead birds, rodents or all vermin and cleaning and disinfecting
- Seasonal Bees management
- To supply and maintain bait boxes on strategic points
- Pest Control for cockroaches, fleas, bird-lice, flies

3. REQUIREMENTS AND CONTRACT DURATION

The Service Provider will be required to provide a comprehensive Pest Control Services. The contract is for a period of three (3) years.

4. PERSONNEL REQUIREMENTS

- All personnel deployed must be trained and in accordance with AGRISETA standards and SAQA.
- With every deployment for fumigation, as a minimum requirement, there must always be one (1) Licensed Operator and one (1) additional technician//assistant.

5. MATERIALS AND CHEMICALS FOR PEST CONTROL

- The Contractor shall supply all chemicals, tools, labour and all equipment necessary for the proper execution of pest control services. Chemicals used must comply with requirements of relevant government authorities and be the least toxic and harmless to humans, eco- friendly chemicals and SABS approved.
- The Contractor is to furnish names of all chemicals/insecticides to be used with the authorities' approval to SABC within 1 month from the award of the contract. Only chemicals approved by the Department of Environment are allowed for application in the premises. It is also the Contractor's responsibility that chemical usage does not defer from laws and regulations stipulated by the local government.
- All insecticides and chemicals must be used discretely. Treatment should not cause damage or be corrosive to the buildings, equipment, and electrical appliances.
- The Contractor must provide the relevant Material Safety Data Sheets (MSDS) for ALL chemicals used in and around SABC premises. It is also the Contractor's responsibility to ensure that an updated list and MSDS be provided to SABC should there be a change.

6. REGULATORY REQUIREMENTS

It is mandatory that the Pest Control Contractor is compliant with the following regulations:

- 6.1. Food Safety Act
- 6.2. Food Safety (General Food Hygiene) Regulations
- 6.3. Occupational Health & Safety Act (85 of 1993)
- 6.4. The Regulations for Hazardous Chemical Substances
- 6.5. Agricultural Pests Act
- 6.6. Fertilizers, Farm Feeds, Agricultural Remedies Act
- 6.7. Natural Environmental Management Act
- 6.8. Foodstuffs, Cosmetics and Disinfectants Act
- 6.9. All other applicable regulations

7. Equipment

The SABC shall not provide any equipment relating to Petrol Control Services for the duration of the contract. Service provider must provide all equipment to render the service efficiently.

8. Access to Building for Services

The contractor will be granted access to the SABC buildings to render services as per the scope of work required.

9. VETTING

SABC is a National Key Point (NKP), and it is important to note that all personnel assigned to service the site will be vetted as an NKP requirement.

10. RFQ Response Information

Vendors should state in writing that their quotation to the SABC and all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service as per the schedule in the **Scope of Service**.

13. EVALUATION CRITERIA

13.1. BBBEE and Price

The RFQ responses will be evaluated on the **80/20**-point system

13.2. Objective Criteria

The SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.

Bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, BBBEE, company financials, etc. will be eliminated from the bid process.

13.3. Technical Evaluation

The tender submission will be technically evaluated out of **75**

A minimum threshold of **55 out of a maximum of 75** has been set.

Bidders achieving less than the set threshold will be declared non-responsive and therefore will not continue forward for evaluation of BBBEE & Price Preference.

7 ADJUDICATION USING A POINT SYSTEM

- 7.1 The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- 7.2 Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 7.3 In the event that two or more bids have scored equal points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 7.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- 7.5 Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

8 POINTS AWARDED FOR PRICE

- I. Bidders who qualify as EME's in terms of the B-BBEE Act must submit a certificate issued by a verification Agency accredited by SANAS for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates or DTI Affidavit.
- II. Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.
- III. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate
- IV. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- V. Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- VI. A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intend sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.
- VII. A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

9 COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

10 CONDITIONS TO BE OBSERVED WHEN TENDERING

- 10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

- Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
- Award a contract to one or more bidder(s).
- Accept any tender in part or full at its own discretion.
- Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BBBEE & Preference Point system.

11 Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under no circumstances be responsible or liable for any such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection process.

12. PAYMENT TERMS

SABC will effect payment sixty (60) days after the service provider has submitted an invoice.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting

business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
