- Future continuation pensioners emanating from the current active and inactive medical scheme members employed by Endumeni Municipality;

To quantify the present value of long service bonus awards liabilities in terms of GRAP 25 for employees eligible to receive long service bonus awards upon attaining the required years of service.

- The Endumeni Municipality seeks to appoint a professional Actuary to conduct valuation of Long-Service Awards and Post Employment Medical Liability valuation

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

CERTIFICATE OF INDEPENDENT BID DETERMINATION
