DESCRIPTION: Appointment of a Service provider to coordinate African Public Space Photo Exhibition in Johannesburg inner-city in April 2024

SPECIFICATION OR TERMS OF REFERENCE (below)

In October 2023, JCPZ in collaboration with the Market Photo Workshop, launched the inaugural Urban Spaces and Public Life Photo Challenge. A call was made to photographers across Africa to submit a selection of works that speak to experience of public spaces in communities across Africa. This initiative aimed to showcase the diverse experiences of public spaces in Africa, receiving 31 submissions from eight countries. The top ten applicants were selected for a three-month mentorship, public exhibition in Johannesburg, and featured works online. A total of 31 submissions from 23 male and 8 female photographers were received. Submissions spanned 8 African countries including (South Africa, Togo, Mali, Benin, Nigeria, Zimbabwe, Lesotho and Uganda).

Some of the questions photographers were invited to think about included:

- What value do people attach to public spaces in your city or in Africa in general?
- How does public space and its making shape the lifestyle of the people who move through them?
- Are the values, identity, histories of people and our present condition represented in public spaces?
- What are the relationships between public space, safety and Gender-Based Violence?
- Is the public built environment approaching issues of climate change?

In addition to promoting new works of social responsibility, activism and ethical investigation by African photographers, the challenge forms part of JCPZ CAPS's initiative to encourage alternative means for gathering and disseminating knowledge and insights into African public spaces.

Against this backdrop, JCPZ is looking for a Service provider to coordinate African Public Space Photo Exhibition in Johannesburg inner-city in April 2024.

Deliverables:

- Develop a detailed project plan outlining key milestones, timelines, and tasks for the photo exhibition.
- Collaborate with Africa photography schools, photographers, artists, and relevant stakeholders to curate selected collection of photos that capture the essence of African public spaces.
- Ensure a diverse representation of cultures, landscapes, and activities in the selected photographs.
- Ensure a smooth flow of the exhibition by overseeing the setup and arrangement of photo displays in the park.
- Organize inclusive engagement activities that cater for photographers that are situated outside South Africa.
- Be aware of the cultural nuances, sensitivities, and diversity inherent in African public spaces to create a respectful and inclusive exhibition experience.
- Working with JCPZ, implement ways of encouraging inner-city local community participation and involvement in the exhibition.
- Identify stakeholders to partner with if JCPZ were to organize mobile photo exhibitions across the continent and globe.
- Develop a comprehensive event report and recommendations on how to develop a long term programme related to urban archiving.

- Proven experience in coordinating cultural events, exhibitions, or visual art projects.
- Familiarity with photography and a passion for promoting cultural diversity.
- Strong organizational and project management skills.
- Excellent communication and interpersonal skills.

- Knowledge of local regulations and permitting processes.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
