SPECIFICATIONS OF GOODS REQUIRED

1. Background

The 6000m³ capacity Collecting Chamber pond is responsible for temporary hold effluent discharged from Mondi, Nsezi Sludge system, Mpact, Felixton Mill and Tronox Exarro Mine during shutdowns or breakdowns on the A-line pipeline.

This pond therefore forms an integral part of the A-line effluent system.

As standard practice to prevent the effluent from infiltrating through the below soil profile layers, thereby contaminating them including the groundwater table- HPDE geo-membrane lining is used to cover and seal the pond on the surface.

Unfortunately, due to wear 'n tear, ageing and UV exposure, the existing pond lining has been damaged in most sections. It is therefore important for the pond lining to be repaired and refurbished to prevent seepage of contained effluent from contaminating the below soil profile.
