Cape Agulhas Municipality is currently awaiting tenders for the Supply, Delivery, Install & Commission of the following Generators:

- 60 KVA 400V 1500 RPM Generator x 5
- 150 KVA 400V 1500 RPM Generator x 4

A tender participation fee of R300 is payable for each set of documents issued. It is estimated that contractors should have a CIDB grading of **3 EB or higher**.

Tenders may only be submitted on the prescribed official document.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the functionality criteria and thereafter for price and preference point system.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the bid.

The Council reserves the right not to accept the lowest or any tender. No telegraphic, telephonic, telex, facsimile, e-mail and late tenders will be accepted. All late submissions will be returned unopened.
