1.1 DESCRIPTION OF SERVICE: STAINLESS STEEL DIGITAL WATERBATH

BACKGROUND: Water baths are essential for DNA and protein extractions as well as for preparation of growth media. Due to the age of the current water baths (10-30 years old) repairs are no longer feasible and a replacement water bath that can be set at different temperatures is required. This will be of value to all current projects and new projects. The long life span of a good quality stainless steel water bath will ensure a good return on investment.

PURPOSE A water bath is used in a laboratory where a constant temperature is required for experiments. It is also used to maintain microbiological agar at a constant temperature before dispensing. Standard water bath should be able to maintain a temperature between room temperature and +/- 100°C. The depth of the water bath is important and needs to be variable to accommodate various sized flasks.
