## 1. INTRODUCTION

- 1.1. The Office of the Pension Funds Adjudicator (OPFA) is a schedule 3A entity established in terms of section 30B of the Pension Funds Act No.24 of 1956 with effect from 1 January 1998 to investigate and determine complaints lodged in terms of the Pension Funds Act in a procedurally fair and expeditious manner.
- 1.2. It is funded in terms of section 30R of the Pension Funds Act by way of a levy imposed by national legislation and collected by the Financial Sector Conduct Authority.
- 1.3. The mandate of the OPFA is to ensure a procedurally fair, economical, and expeditious resolution of complaints in terms of the ACT, by:
  - Ensuring that its services are accessible to all
  - Investigating complaints in a procedurally fair manner
  - Reaching a just and expeditious resolution of complaints in accordance with the ACT.

## 2. PURPOSE AND SCOPE OF THE REQUIRED GOODS AND SERVICES

- 2.1. The purpose of this RFQ is to appoint a qualified and authorised service provider to supply, implement, configure, and support the FortiNAC solution from Fortinet.
- 2.2. The OPFA requires the procurement and implementation of a Network Access Control (NAC) solution to enhance visibility, control, and security of devices accessing its network environment.
- 2.3. This specification is to define the scope, deliverables, support services required for the procurement and implementation of FortiNAC Solution for OPFA which will include the following:
  - i. FortiNAC Control and Application Extended-VM – 1 Year FortiCare Premium Support
  - ii. FortiNAC Control and Application Extended-VM – Next-Generation VM Server (VMWare/Hyper-V/AWS/Azure/KVM compatible)
- 2.4. The solution must strengthen OPFA's network access control capabilities and align with existing virtual infrastructure.

## 3. SCOPE OF WORK

- 3.1. The appointed service provider will be responsible for:
  - 3.1.1. Supply of required FortiNAC licenses and subscriptions
  - 3.1.2. Activation of 1-Year FortiCare Premium Support
- 3.2. **Implementation & Configuration**
  - 3.2.1. Deployment of the FortiNAC Extended-VM solution
  - 3.2.2. Configuration within OPFA's virtual environment (Hyper-V)
  - 3.2.3. Integration with existing network and security infrastructure
  - 3.2.4. Policy configuration for device visibility and access control
  - 3.2.5. System testing and validation
  - 3.2.6. Go-live support

### 3.3. **Documentation & Knowledge Transfer**

- 3.3.1. Configuration documentation
- 3.3.2. System architecture documentation
- 3.3.3. Administrative and operational handover
- 3.3.4. Knowledge transfer session(s) to designated OPFA IT personnel

### 3.4. **Support Requirements**

3.4.1. The appointed service provider must provide:

- **FortiCare Premium Support (1 Year)**
- **48 hours of ad hoc technical support**, which:
  - Will be utilised upon formal request by OPFA and must be logged and tracked.
  - Will be claimable only once work has been completed
  - Must remain valid for the 12 months duration of the support period

3.4.2. The bidder must specify:

- Support response and resolution times (SLA)
- Escalation procedures
- Support availability (business hours / after-hours)
- Hourly rates for additional support beyond the 48 hours

### 3.5. **Deliverables**

3.5.1. The service provider must deliver:

- Fully installed and configured FortiNAC solution
- Valid licenses and support subscriptions
- Technical and operational documentation
- Test and commissioning report
- Knowledge transfer completion confirmation
- Final project sign-off document

- The OPFA will extract further CSD reports from the CSD system during the evaluation of bids. It is the responsibility of the Bidders to ensure information is updated and correct as per the points being claimed.

## 7. PROTECTION OF PERSONAL INFORMATION ACT (POPIA)

- 7.1. "POPIA" shall mean the Protection of Personal Information Act (Act Number 4 of 2013), as amended from time to time.
- 7.2. Personal Information" (PI) shall mean the race, gender, sex, pregnancy, marital status, national or ethnic origin, colour, sexual orientation, age, physical or mental health, disability, religion, conscience, belief, culture, language and birth of a person; information relating to the education or the medical, financial, criminal or employment history of the person; any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other particular assignment to the person; the biometric information of the person; the personal opinions, views or preferences of the person; correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence; the views or opinions of another individual about the person whether the information is recorded electronically or otherwise.
- 7.3. The parties acknowledge that for the purposes of this bid and agreement the parties may come into contact with or have access to PI and other information that may be classified, or deemed as private or confidential and for which the other party is responsible. Such PI may also be deemed or considered as private and confidential as it relates to any third party who may be directly or indirectly associated with this agreement. Further, it is acknowledged and agreed by the parties that they have the necessary consent to share or disclose the PI and that the information may have value.
- 7.4. The parties agree that they will always comply with POPIA's Regulations and Codes of Conduct and that it shall only collect, use and process PI it meets pursuant to this agreement in a lawful manner, and only to the extent required to execute the services, or to provide the goods and to perform their respective obligations in terms of this agreement.
- 7.5. The parties agree that it shall put in place, and always maintain, appropriate physical, technological, and contractual security measures to ensure the protection and confidentiality of PI that it, or its employees, its contractors or other authorized individuals meets pursuant to this agreement.
- 7.6. Notify each other immediately where it has reasonable grounds to believe that the Personal Information in respect of this agreement, which has been provided to it including any Personal Information which it has processed, has been lost, destroyed, or accessed or acquired by any unauthorized person.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) “**price**” means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) “**Rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.

$$P_s = 80 \left( 1 - \frac{P_t - P_{min}}{P_{min}} \right) \text{ or } P_s = 90 \left( 1 - \frac{P_t - P_{min}}{P_{min}} \right)$$

Where

$P_s$  = Points scored for price of tender under consideration

$P_t$  = Price of tender under consideration

$P_{min}$  = Price of lowest acceptable tender

### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$P_s = 80 \left( 1 + \frac{P_t - P_{max}}{P_{max}} \right) \text{ or } P_s = 90 \left( 1 + \frac{P_t - P_{max}}{P_{max}} \right)$$

Where

$P_s$  = Points scored for price of tender under consideration

$P_t$  = Price of tender under consideration

$P_{max}$  = Price of highest acceptable tender

**4. POINTS AWARDED FOR SPECIFIC GOALS**

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system: or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
