# Ora will soon be SA's most affordable electric vehicle

SET to go on sale later this year, the GWM Ora will be South Africa's most affordable electric vehicle (EV).

The Chinese carmaker has revealed local pricing for the EV, with the Ora selling from R716 900 for the base model, up to R915 900 for the range-topping version.

At that starting price, the Ora

will dethrone the Mini Cooper SE as the current cheapest local EV option at R742 102.

In overseas markets, buyers get to choose between 48kWh and 63kWh batteries, allowing for claimed Worldwide Harmonised Light Vehicle Test Procedure (WLTP) range figures of up to 310km and 420km respectively.

Whether or not the South African market will get both battery options remains to be seen. GWM says the Ora will charge from 10% to 80% in 40 minutes when connected to an 80kW DC charger.

Power comes from a single electric motor that produces 126kW and 250Nm.

In terms of size, the 4.23m-long Ora 300 has a similar footprint to the Volkswagen T-Roc and Hyundai Kona.

The vehicle also has a five-star Euro NCAP rating.
